Reduced Tuition Policy

Students who attend Bank Street School for Children and receive financial aid for tuition do not need to complete this form. Your reduced tuition is based on your child(ren)'s aid percentage(s) from the 2025-26 school year.

Financial Aid awards at Bank Street Summer Camp are granted to campers on the basis of family need and availability of aid. Awards are granted for one year at a time and must be applied for annually. The maximum award is 25% of the tuition. Families will be notified of their award by April 10, 2026. Applications received after March 13, 2026 will be reviewed and awarded based on availability of funds. The financial aid committee will review complete applications only.

Full payment for all Summer Camp balances are due June 1, 2026.

If you withdraw from Summer Camp before June 1 and after the financial aid is awarded, you will be refunded your deposit minus the \$65 registration fee per child.

If you are applying for reduced summer tuition, please make sure:

1. Your child(ren) is registered for summer camp online.
2. You have paid the non-refundable registration fee of \$65 per child.
