#### DAIRY MARKET NEWS AT A GLANCE

#### CME GROUP CASH MARKETS (8/8)

**BUTTER:** Grade AA closed at \$2.3550. The weekly average for Grade AA is \$2.4175 (-0.0610).

CHEESE: Barrels closed at \$1.7975 and 40# blocks at \$1.8500. The weekly average for barrels is \$1.7845 (+0.1185) and blocks \$1.8115 (+0.1325).

NONFAT DRY MILK: Grade A closed at \$1.2650. The weekly average for Grade A is \$1.2760 (-0.0130).

**DRY WHEY:** Extra grade dry whey closed at \$0.5800. The weekly average for dry whey is \$0.5640 (+0.0250).

BUTTER HIGHLIGHTS: Many sellers indicate domestic food service demand is down this year. Domestic retail butter demand is stronger in the West region, steady in the Central region, and lighter in the East region. Demand from international buyers is mixed throughout the country as well. Spot cream availability is looser with production of a few other dairy products, such as ice cream, slowing down. In some cases, plant downtime or higher cream prices are moving spot cream away from butter churns and into Class II or Class III dairy product manufacturing. Butter production schedules are mixed. Bulk butter overages range from 5 cents below to 5 cents above market across all regions.

CHEESE HIGHLIGHTS: Cheese manufacturers in the Northeast are purchasing spot loads for condensed skim to help fortify production. Cheesemakers in the Central region are running steady to lighter schedules as some plant managers say tight spot volumes and increasing demand from Class I processors is reducing their ability to run full schedules. Domestic demand varies from steady to light. Demand from international buyers varies from steady to strong. Stakeholders indicate prices for U.S. cheese remain competitive compared to prices for internationally produced cheese.

FLUID MILK HIGHLIGHTS: Milk production is lighter and milk components are decreasing seasonally nationwide. Raw milk production remains sufficient to meet industry demand. Year over year milk production remains higher in 2025 than in 2024. Class I bottling is increasing in the Southeast and Southwest due to educational institutions beginning the fall semester. The remainder of the U.S. notes normal bottling operations for this time of year. Class II production is starting to decline. Contacts note a drop in hard pack ice cream manufacturing is occurring earlier in the summer than anticipated. Class III production is steady but trending lighter this week. Class III milk is trading within a tighter range this week; \$1-under to \$2-over. Some cheesemakers say they continue to purchase Class III milk that is available due to downtime at nearby production facilities at or below Class III prices. Cream production is lighter in most regions. Butter production is slow, making cream widely available for spot purchases. East and West regions cream multiples were unchanged. Central region cream multiples dropped slightly for the top end of the range. Condensed skim production is heavy. Sales activity is strong in the Northeast and is light to steady in other regions. Sales of condensed skim are going for \$0.20 to \$0.30 over Class price.

**DRY PRODUCTS HIGHLIGHTS:** Low/medium heat nonfat dry milk (NDM) prices declined across the range in the West this week, and the top of the price range for the Central and East regions declined. Contacts in the Central and West regions say demand from purchasers in Mexico is declining. High heat NDM prices remained steady throughout the country. Prices moved lower at the top of the range for dry buttermilk in every region. In the West, dry buttermilk demand is steady to lighter. The bottom of the price range for dry whole milk slid lower. In the Central region, dry whey prices increased at the top of the range but moved lower at the bottom. Prices decreased across the West dry whey price range but held steady in the Northeast. Animal feed whey prices are unchanged. The price ranges for lactose, whey protein concentrate 34%, acid casein, and rennet casein were all unchanged this week.

**ORGANIC DAIRY MARKET NEWS:** The Pennsylvania Monthly Organic Dairy Report, a report created as part of the Organic Dairy Initiative sponsored by the 2018 farm bill, covering May 2025 was released on August 8, 2025. This report showed the weighted average price for fluid milk increased by 0.52% from April. The Vermont Monthly Organic Dairy Report, a report created as part of the Organic Dairy Initiative sponsored by the 2018 farm bill, covering May 2025 was released on August 8, 2025. This report showed the weighted average price for fluid milk decreased 11.94% from April. The Foreign Agricultural Service (FAS) releases monthly export data which includes export volumes and values for organic milk categorized as HS-10 code 0401201000. Recently released data for June 2025 indicated organic milk exports were 388,978 liters, up 47.0 percent from the month prior, and up 38.7 percent from June 2024.

JUNE DAIRY PRODUCTS HIGHLIGHTS (NASS): Butter production was 185 million pounds, 10.4 percent above June 2024 but 12.5 percent below May 2025. American type cheese production totaled 473 million pounds, 4.8 percent above May 2024 and 7.1 percent below May 2025. Total cheese output (excluding cottage cheese) was 1.20 billion pounds, 4.2 percent above June 2024 but 3.9 percent below May 2025. Nonfat dry milk production, for human food, totaled 140 million pounds, 9.6 percent above June 2024, and 10.5 percent below May 2025. Dry whey production, for human food, was 73.6 million pounds, 0.7 percent above June 2024, and 2.9 percent above May 2025. Ice cream, regular hard production, totaled 64.9 million gallons, 3.9 percent below June 2024, and 0.8 percent above May 2025.

NATIONAL RETAIL REPORT: Total conventional dairy ads are down 4 percent in the week 32 retail ad survey, but organic dairy ads increased 162 percent. Conventional cheese, the most advertised conventional dairy commodity, appeared in 12 percent more ads this week. Greek yogurt in 4-6-ounce containers, the most advertised conventional yogurt product, appeared in 28 percent fewer ads this week. Conventional milk ads are down 30 percent.

#### **BUTTER MARKETS**

EAST WEST

Butter production remains seasonally slow in the Northeast. Manufacturers are taking advantage of higher cream multiples and sending cream to Class II and Class III producers rather than the churn. Cream multiples in the Northeast will not change this week. With slower churn activity and other commodity manufacturing slowing, cream is readily available for spot purchasing. Contacts report slower sales of retail and food service size packages. Bulk butter sales remain slow with reported sales at or below the CME. International sales are slow this week. Inventories of bulk butter remain healthy.

#### CENTRAL

Cream production is declining in the Central region, following seasonal trends. Spot volumes of cream are available as ice cream purchasers are reducing their spot orders, and some butter makers say they are selling spot loads of cream due to scheduled maintenance. Outside of some plants with scheduled downtime, butter makers say they are actively churning. Spot loads of butter are available for purchasing and some butter makers say they are freezing loads of butter for use later in the year. Domestic butter demand remains steady, but light. Export butter sales are strong and butter makers report demand for 82 percent butterfat butter is outpacing production, keeping inventories for these loads tighter.

Butter manufacturers are receiving contractual cream volumes, despite fat components in milk outputs decreasing. Demand for cream from ice cream producers is lightening, leaving more spot cream available for butter manufacturers. Cream demand for butter churning is mixed. Plant downtime, churning equipment replacement, and cream prices are contributing to unsteady spot cream demand from butter producers. Butter production schedules vary from steady to stronger. Salted butter is readily available, while unsalted butter from some producers is somewhat tight for spot buyers. Domestic demand is stronger. However, many sellers convey sales for the food service sector are down this year. Export demand is steady.

#### **CHEESE MARKETS**

#### **EAST**

CME prices are on the rise. Last week the CME price for barrels rose \$0.085 and this week, at time of reporting, barrel pricing is up an additional \$0.08. Blocks rose \$0.065 last week and \$0.0975 at the time of reporting. Manufacturing of Class III remains steady this week. Cheese manufacturers in the Northeast are purchasing spot loads of condensed skim to help fortify production. Retail and food service demand is keeping up with production schedules. Inventory levels of cheese are steady. Export demand remains steady.

#### **CENTRAL**

Milk output continues to decline seasonally in the Central region as contacts say recent high temperatures are negatively impacting cow comfort. At report publication, reported Class III milk prices range from \$1-under to \$2-over. Some contacts say spot volumes are available nearby due to downtime at other production facilities, but overall spot milk volumes are tight. Curd demand is steady, while retail and food service sales remain light. International purchasers are steadily ordering spot loads of cheese. Cheesemakers are running steady to lighter schedules as some plant managers say tight spot volumes and increasing demand from Class I processors is reducing their ability to run full schedules.

#### WEST

Cheese manufacturers convey milk output is strong enough to keep up with contractual obligations in the West. Class III spot milk demand is steady from cheese manufacturers. Class III spot milk availability is steady for most of the region, but not in robust quantities. Cheese production schedules are steady. Varietal cheese loads are widely available for spot buyers. Domestic demand varies from steady to light. Demand from international buyers varies from steady to strong. CME trading prices moved noticeably upward for cheese barrels and cheese blocks for the first two trading days of week 32. Stakeholders indicate prices for US cheese remain competitive compared to prices for internationally produced cheese.

#### **FOREIGN**

Demand from the retail sector for foreign type cheese is steady for the mostly. Stakeholders indicate European holidays are not significantly impacting. Demand from food service sector for foreign type cheese is steady. Stakeholders indicate cooler summer temperatures in some parts of Europe are decreasing activity in comparison to seasonal expectations from the food service sector. Demand from southern European buyers is seasonally strong. Industry sources convey unsteady currency rates and trade policies are negatively contributing to export sales activity for some sellers. European milk production is lighter. Herd health issues for some dairy farms in France are negatively impacting farm level milk output. European cheese production varies from steady to lighter. Cheese stocks are meeting demands, but they are not robust. Market tones are stable.

#### NONFAT DRY MILK - CENTRAL AND EAST

In the Central and East regions, prices for low/medium heat nonfat dry milk (NDM) moved lower at the top of the range, but the bottom of the range and both ends of the mostly price series were unchanged this week. Low/medium heat NDM demand is steady to lighter in domestic and international markets. Contacts report interest from purchasers in Mexico is declining, but sales to the country remain strong overall. Spot loads of low/medium heat NDM remain tight in the Southwest, but contacts anticipate lighter exports will increase availability in the coming weeks. In other parts of the Central and East regions, spot purchasers say spot loads remain available to meet current demand. Declining milk output in the Central and East regions is reducing the volume of condensed skim milk available for drying. Low/medium heat NDM production schedules are lighter this week, and plant managers report high heat NDM production remains limited. Spot high heat NDM inventories are tight, but well balanced with light demand. High heat NDM prices are unchanged.

#### **NONFAT DRY MILK - WEST**

In the West, low/medium heat nonfat dry milk (NDM) prices moved one cent lower for both ends of the range and the top end of the mostly price series. The bottom end of the mostly price series is unchanged. Domestic demand is steady. Demand from international buyers is lighter. Sellers indicate sales activity with Mexico buyers is ticking down. Stakeholders convey buyers are purchasing for short term needs more than securing loads for long term needs. High heat NDM prices are unchanged for week 32. Both steady and intermittent production schedules are reported. Demand for high heat NDM is steady.

#### DRY BUTTERMILK - CENTRAL AND EAST

The buttermilk powder (BMP) market is balanced, one contact stated. Despite production being slow, there is enough BMP to meet current demand. A recent decline in butter production is the primary cause for decline in production. The BMP price range dropped at the top end of the range, but the bottom remained the same. BMP Inventories remain tight, and availability is limited.

#### **DRY BUTTERMILK - WEST**

Dry buttermilk prices moved two cents lower for the top of the range and mostly price series in the West. The bottom ends of the range and mostly price series are unchanged this week. Demand from domestic and international buyers varies from steady to lighter. Load availability from manufacturers in the region is tight for spot buyers. Distributors and traders indicate there are loads for spot buyers to secure, but load availability is somewhat tight for parts of the region. Dry buttermilk production schedules are mixed. The busyness of butter production schedules varies throughout the region making less liquid/condensed buttermilk for drying in some cases.

#### DRY WHOLE MILK

The dry whole milk price range edged slightly higher at the bottom this week. Production continues to be focused on fulfilling contracts, with little production available beyond that. Spot market interest was subdued.

#### WHEY, WPC 34%, LACTOSE, & CASEIN

Prices represent carlot/trucklot quantities for domestic and export sales packaged in 25 kg. or 50 lb. bags, or totes, spray process, dollars per pound.

#### DRY WHEY- CENTRAL

The Central region dry whey price range expanded this week, as contacts reported lower prices at the bottom of the range and higher prices at the top. The mostly price series shifted lower in the Central region. Demand for dry whey is declining in the region and contacts say export sales remain light. Spot loads of dry whey are available for purchasing, but stakeholders say interest in some brands of dry whey is stronger than others keeping inventories for these brands tight. Dry whey production remains limited as drying schedules remain focused on higher whey protein concentrates and whey protein isolate. Animal feed whey prices were unchanged this week. Contacts report limited spot market activity for animal feed whey amid light demand and tight inventories.

#### DRY WHEY-EAST

The whey market was active this week. Cheese production remains steady, providing a healthy supply of whey for the market. Extra Grade whey pricing on the CME is up this week. At time of reporting, the CME was at \$0.56. The National Dairy Products Sales Report (NDPSR) is also up this week with a price of \$0.5747 for week ending 8/2/25. The price range in the East will remain the same this week. Contacts report an increase of price inquiries from international buyers for future loads of whey to Asia . Whey inventories are sufficient for current customer demand.

#### DRY WHEY- WEST

In the West, dry whey prices moved one cent lower for both ends of the range and the top end of the mostly price series. The bottom end of the mostly price series is unchanged for this week. Demand from domestic and international buyers varies from steady to lighter. Stakeholders describe the availability of dry whey loads as being comparatively tighter in the West region than the neighboring Central region. Extra grade dry whey production schedules are steady, but grade A dry whey production schedules are more variable. For a few manufacturers only extra grade dry whey is being produced.

#### WHEY PROTEIN CONCENTRATE

The price range and mostly series for whey protein concentrate 34% (WPC 34%) held steady this week. Demand remains firm, supported by tight spot inventories and light production. Loads meeting higher-grade nutritional specifications continue to be priced near the top of the range. Most spot trading is occurring at levels competitive with nonfat dry milk.

#### LACTOSE

The lactose price range and mostly series were unchanged from last week, reflecting a market continuing to demonstrate underlying strength and consistency. Demand remains robust, with contacts noting production is ramping up to meet both contracts and spot needs. Inventories are described as tight, particularly for loads aligned with Q3 contracts. A few spot trades were reported, including loads trading just outside of typical ranges. Market tone remains firm, supported by stable domestic interest and a measured pace of international activity.

#### **CASEIN**

Prices for both acid and rennet casein held steady this week. Acid casein demand is strengthening in Oceania, and contacts report steady interest from purchasers in other regions. Milk output is increasing in Oceania and plant managers say acid casein production is trending higher. Spot purchasers report acid casein inventories remain snug as demand continues to outpace production in Oceania. Rennet casein production is declining seasonally in Europe and demand is declining within the region. In other regions, demand for rennet casein is steady. Contacts report rennet casein is available to meet current market demands, but inventories are tightening in Europe.

The Pennsylvania Monthly Organic Dairy Report, a report created as part of the Organic Dairy Initiative sponsored by the 2018 farm bill, covering May 2025 was released on August 8, 2025. This report showed the weighted average price for fluid milk increased by 0.52% from April. The total volume of milk produced increased in May, but the average daily production per cow decreased. The Vermont Monthly Organic Dairy Report, a report created as part of the Organic Dairy Initiative sponsored by the 2018 farm bill, covering May 2025 was released on August 8, 2025. #### ORGANIC DAIRY FLUID OVERVIEW

The Foreign Agricultural Service (FAS) releases monthly export data which includes export volumes and values for organic milk categorized as HS-10 code 0401201000. Recently released data for June 2025 indicated organic milk exports were 388,978 liters, up 47.0 percent from the month prior, and up 38.7 percent from June 2024. Exports of organic milk from the start of the year through June, 2,383,124 liters, are up 125.5 percent, compared to the same time period one year ago.

A large Dutch organic milk processor announced that the guaranteed price for organic farm milk in August 2025 is 66.50 EUR/100kg (\$77.48 USD), unchanged from July 2025. The processor stated they anticipate reference companies will keep prices steady in August. The guaranteed organic price applies to 100kg of milk with standard contents protein (3.58%), fat (4.45%), and lactose (4.53%). The amounts apply to an average supply of 550,000 kg of milk annually.

A cooperative announced their July organic milk pay price in the UK is unchanged from the previous month, 57.86 pence (\$0.78 USD) per liter. The announcement stated milk supplies are growing globally, retail sales are slowly growing, and commodity markets are volatile.

In a recent report from a Pacific Northwest livestock auction, the top 10 organic cull cows and the overall average for organic cull cows traded lower than the top 10 conventional cull cows. The average price for the top 10 organic cows auctioned was \$112.28 per hundredweight, compared to an average price of \$171.33 per hundredweight for the top 10 conventional cows auctioned. The average weight for the top 10 conventional cows was 1,682.0 pounds compared to 1,209.0 pounds for the top 10 organic cows. The overall price for organic cows auctioned was \$112.28 per hundredweight with an average weight of 1,012.29 pounds, while the overall price for conventional cows auctioned was \$129.15 per hundredweight with an average weight of 1,202.10 pounds.

The following was reported by USDA AMS Livestock, Poultry, and Grain Market News in the National Organic Grain and Feedstuffs Report. Compared to last period, spot market trade activity for organic feed corn, soybeans, and wheat was moderate, active for forward contracts. Organic feed corn sold 81 cents lower delivered elevator with forward contracts delivering Q3 2025 through Q3 2027. Organic feed soybeans sold 38 cents higher delivered with forward contracts delivering Q4 2025 through Q3 2027. Organic feed wheat sold 25 cents higher delivered with forward contracts delivering Q3 2025. The bulk of the market activity this period was forward contracting with buyers procuring grain as far out as Q4 2027. The next report will be published Wednesday, August 20, 2025.

#### NATIONAL ORGANIC GRAIN AND FEEDSTUFFS

Compared to last period, organic feed corn trade activity is moderate with good demand. Corn sold 51 cents lower delivered elevator with the bulk of trade forward contracts delivering Q2 2025 through Q3 2026. Organic feed soybean trade activity is light with good demand. Soybeans sold 55 cents lower delivered elevator with forward contracts delivering Q2 2025 through Q1 2026. Cash bids in the Midwest are moving higher. Organic feed wheat trade activity is light with good demand. Soft Red Winter and Hard Red Winter feed wheat sold 15 cents lower delivered elevator with forward contracts delivering Q2 2025 through Q3 2025. Organic soybean oil prices are unchanged from the last period. Trade is inactive for all other organic grains. The next report will be published Wednesday, June 25, 2025.



#### ORGANIC DAIRY RETAIL OVERVIEW

In the week 32 retail survey, total organic dairy ads increased 162 percent. Every commodity present in the week 31 survey appeared in more ads this week. Organic milk ads grew 554 percent and overtook yogurt and butter to become the most advertised organic commodity this week. Cheese had the largest percentage growth in ads of any organic dairy commodity, 646 percent.

#### Percentage of Total Organic Ads by Commodity



Ads for half gallon and gallon organic milk increased in week 32. Organic half gallon milk ads increased 700 percent, the largest percentage growth for any organic dairy product found in last week and this week's survey, and remained the most advertised organic milk product. The weighted average advertised price (average price) for organic half gallon milk declined 96 cents to \$4.55. Conventional half gallon milk has an average price of \$1.63, creating an organic premium of \$2.92.

Cheese is the second most advertised organic dairy commodity this week. Organic 6-8-ounce block cheese was absent from the prior survey but appeared this week and ads increased for every organic cheese product that appeared in last week's report. Organic 6-8-ounce shred style cheese ads are up 495 percent, and the average price is \$4.42, down 7 cents. This product's conventional counterpart has an average price of \$2.57, creating an organic premium of \$1.85.

Despite appearing in 19 percent more ads, ice cream fell from the most advertised organic dairy to the third in week 32. Organic 14-16-ounce ice cream increased 80 percent and appeared in more ads than any other ice cream product. The average price for 14-16-ounce ice cream increased 7 cents to \$6.68. Conventional 14-16-ounce ice cream's average price is \$3.69. The organic premium for this product is \$2.99.

Organic yogurt had the smallest percentage growth for any organic dairy commodity this week, increasing 5 percent. Ads for the most advertised organic yogurt product, 32-ounce regular style, are up 25 percent. This product's average price increased 32 cents to \$5.35. Conventional 32-ounce regular yogurt has an average price of \$2.83, making this week's organic premium \$2.52.

# **June 2025 Dairy Products Highlights**

Butter production was 185 million pounds, 10.4 percent above June 2024 but 12.5 percent below May 2025. American type cheese production totaled 473 million pounds, 4.8 percent above May 2024 and 7.1 percent below May 2025. Total cheese output (excluding cottage cheese) was 1.20 billion pounds, 4.2 percent above June 2024 but 3.9 percent below May 2025. Nonfat dry milk production, for human food, totaled 140 million pounds, 9.6 percent above June 2024, and 10.5 percent below May 2025. Dry whey production, for human food, was 73.6 million pounds, 0.7 percent above June 2024, and 2.9 percent above May 2025. Ice cream, regular hard production, totaled 64.9 million gallons, 3.9 percent below June 2024, and 0.8 percent above May 2025.





### Advertised Prices for Dairy Products at Major Retail Supermarket Outlets ending during the period of 8/8/2025 to 8/14/2025


Total conventional dairy ads are down 4 percent in the week 32 retail ad survey, but organic dairy ads increased 162 percent. Conventional cheese, the most advertised conventional dairy commodity, appeared in 12 percent more ads this week. Ads for the most advertised organic commodity, milk, are up 554 percent.

Organic cheese appeared in 646 percent more ads this week to become the second most advertised organic commodity. The most advertised conventional cheese product is 6-8-ounce sliced. Ads for this product grew 40 percent, and the weighted average advertised price (average price) increased 44 cents to \$2.95. Organic 6-8-ounce sliced cheese ads are up 285 percent and the average price, \$5.29, is up 80 cents. The organic premium for 6-8-ounce sliced cheese is \$2.34.

Conventional ice cream ads declined by 9 percent, but organic ice cream ads grew 19 percent in this week's survey. Ads for 48-64-ounce conventional ice cream are down 7 percent. This product's average price is down 19 cents to \$3.55. Organic 48-64-ounce conventional ice cream appeared in 57 percent fewer ads this week. The average price for this product increased 88 cents to \$10.49, creating an organic premium of \$6.94.

Ads for conventional yogurt are down 23 percent, while organic yogurt ads increased 5 percent. Greek yogurt in 4-6-ounce containers, the most advertised conventional yogurt product, appeared in 28 percent fewer ads this week. The average price for this product is up 4 cents to \$1.15. There are no ads for organic 4-6-ounce Greek yogurt this week.


Conventional milk ads are down 30 percent. Total ads for conventional gallons of milk are up 25 percent, while the average price is down 31 cents to \$2.92. Organic gallons of milk appeared in 39 percent more ads this week. The average price for this item declined 14 cents to \$8.61, creating an organic premium of \$5.69.




Top 5 Commodities Featured This Week
