Supply included: 59% Feeder Cattle (100% Steers); 22% Slaughter Cattle (84% Cows, 16% Bulls); 19% Replacement Cattle (36% Stock Cows, 55% Bred Cows, 9% Bred Heifers). Feeder cattle supply over 600 lbs was 0%.
