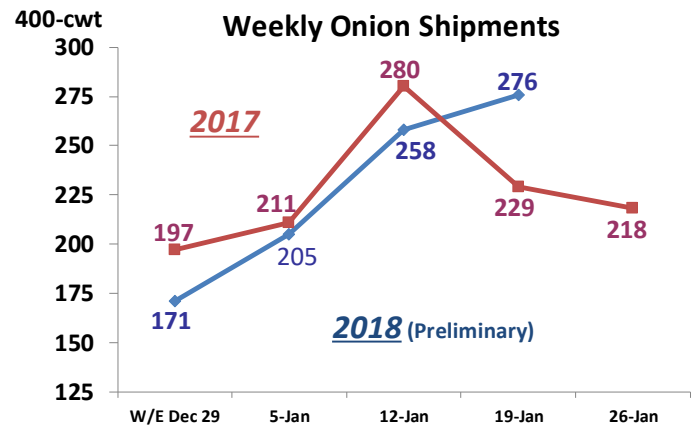


IDAHO & MALHEUR COUNTY, OR Weekly Onion Shipments

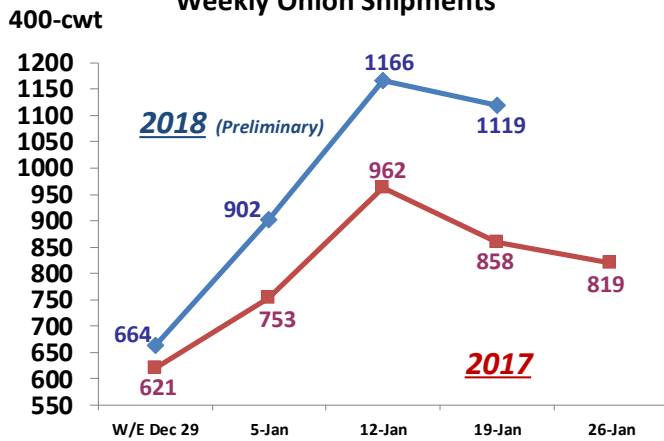

Weekly Onion Shipments

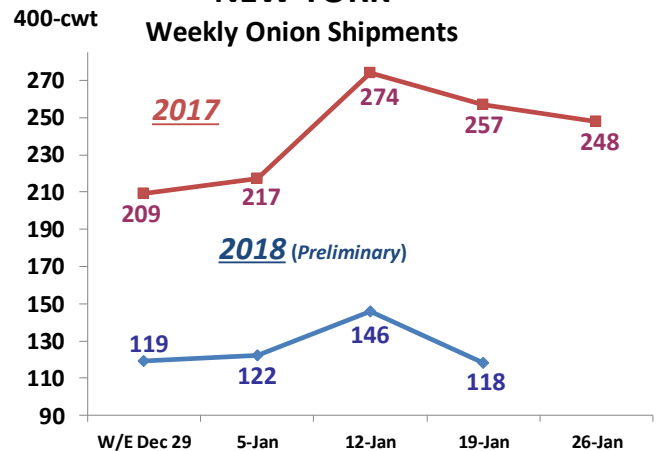


COLUMBIA BASIN, WASHINGTON Weekly Onion Shipments

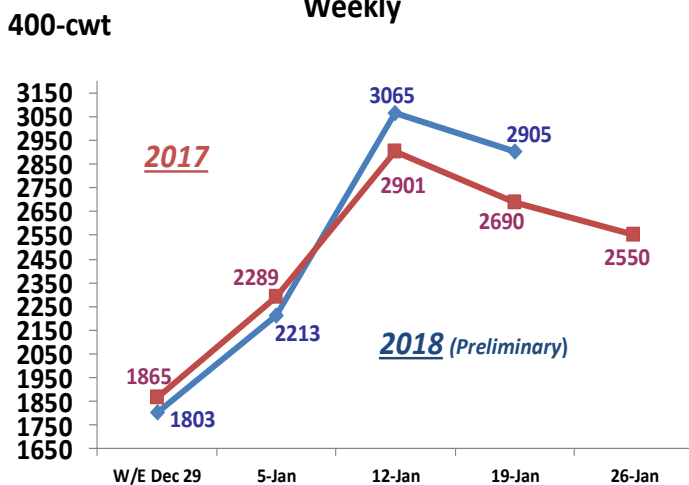

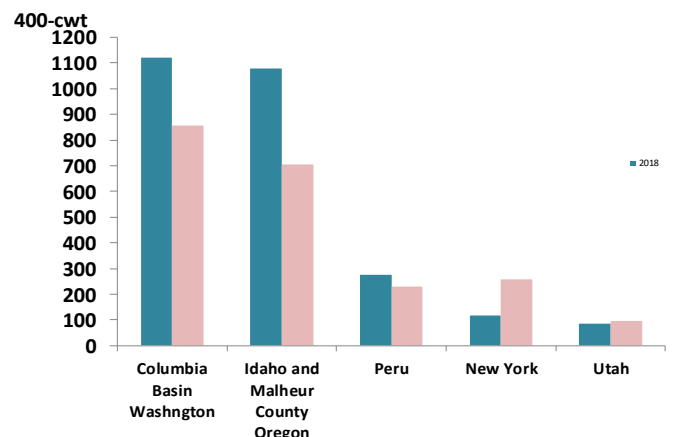
