National Broiler Market-At-A-Glance

Whole broiler/fryer prices are mostly steady. Offerings of all sizes are light to moderate for current trade needs. Retail demand is in a full range, mostly light to moderate. Food service is moderate with some improvement expected for the weekend. Floor stocks are mixed with some orders expected to increase to fulfill Valentine's Day needs. Market activity is slow to moderate. In the parts structure, breast items are steady to firm and dark meat cuts are generally steady. Offerings of bone-in breasts and tenderloins are light at best, balance of items are light to moderate, with some finding thigh meat more available. Market activity is slow to moderate. In production areas, live supplies are moderate at mostly desirable weights.

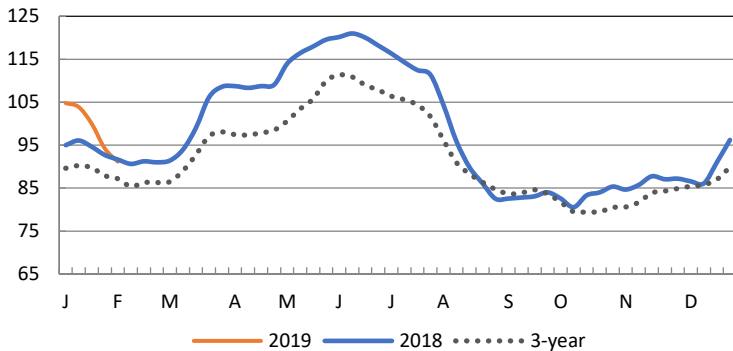

Prices of 15-20% MSC are trending mostly steady for frozen and steady to slightly higher for fresh. The undertone is steady. Spot market domestic and export demand is in a range of light to moderate. There was raw material interest noted into pet food and export channels. Supplies are moderate to instances light. Processing schedules return to normal. Market activity is slow to moderate. Supplies of raw materials are mixed, varying by area. Frame prices are trading at 8-10 cents FOB.

Broiler Hatchery

Broiler-Type Eggs Set in the United States Up 1 Percent

Hatcheries in the United States weekly program set 229 million eggs in incubators during the week ending February 2, 2019, up 1 percent from a year ago. Average hatchability for chicks hatched during the week in the United States was 82.1 percent. Average hatchability is calculated by dividing chicks hatched during the week by eggs set three weeks earlier.

Broiler-Type Chicks Placed in the United States Up 2 Percent

Broiler growers in the United States weekly program placed 183 million chicks for meat production during the week ending February 2, 2019, up 2 percent from a year ago. Cumulative placements from the week ending January 6, 2018 through February 2, 2019 for the United States were 913 million. Cumulative placements were up slightly from the same period a year earlier.
