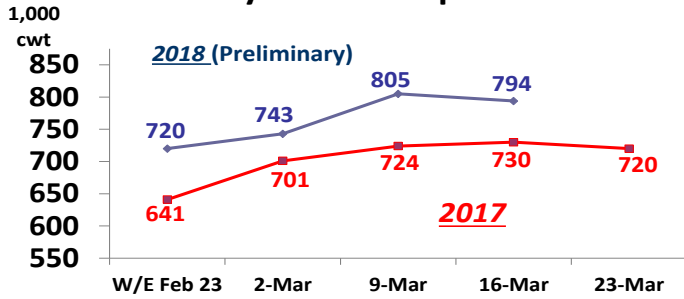

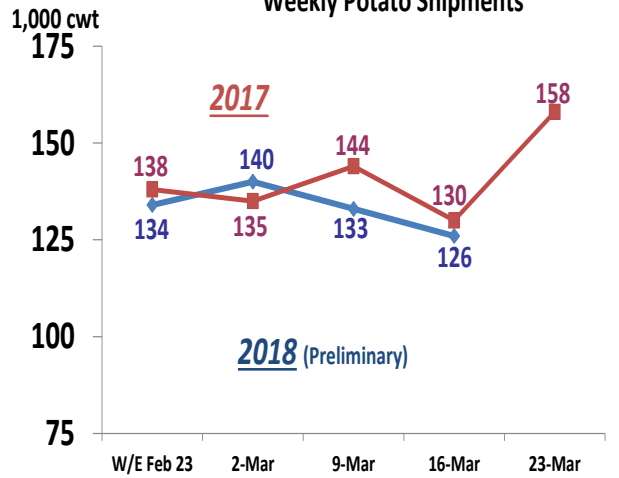

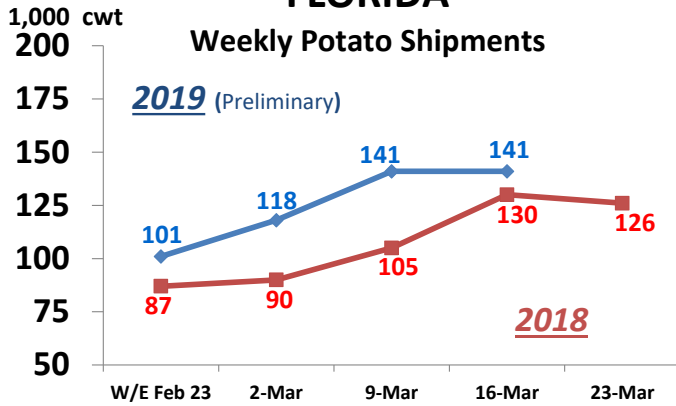
IDAHO Weekly Potato Shipments



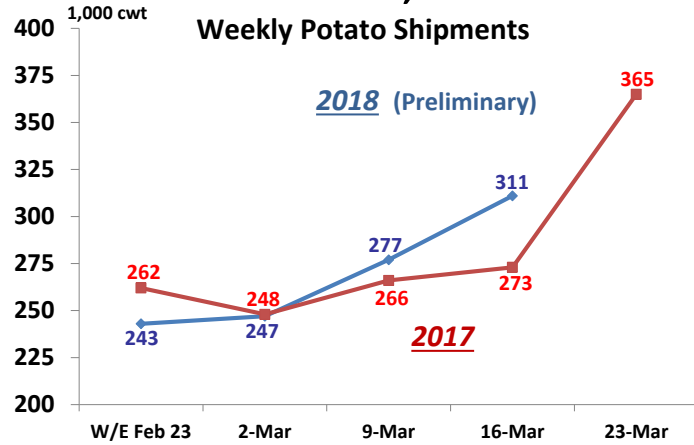
COLUMBIA BASIN, WA & UMATILLA BASIN, OR Weekly Potato Shipments



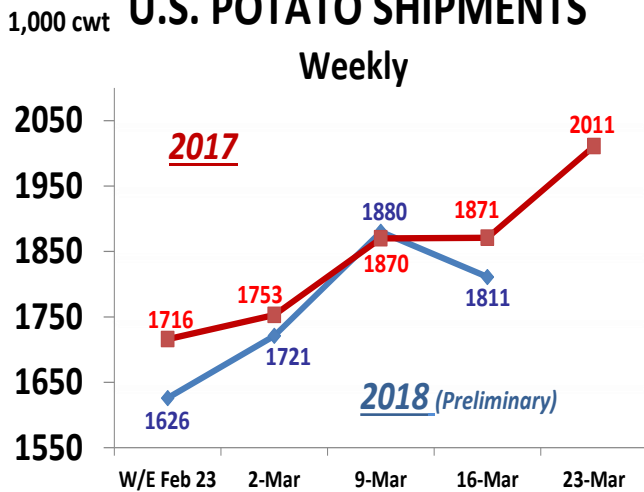
FLORIDA Weekly Potato Shipments



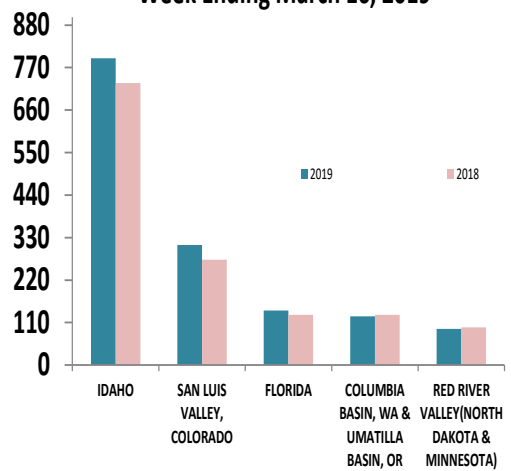
SAN LUIS VALLEY, COLORADO Weekly Potato Shipments



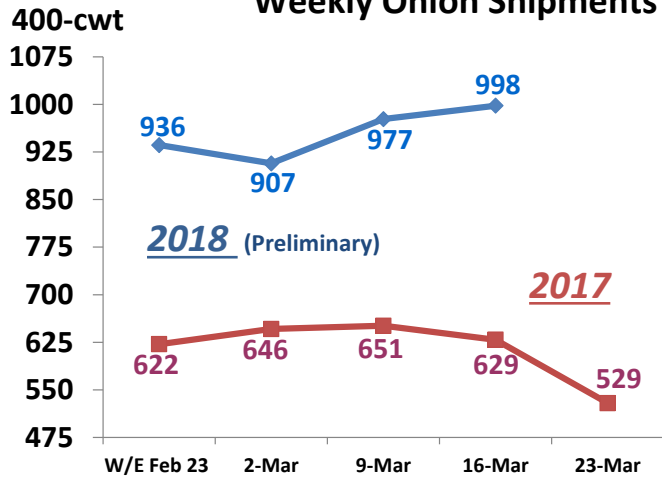

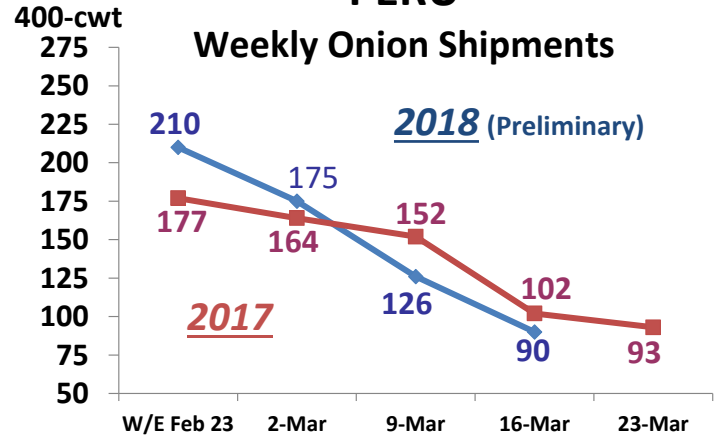
TOP 5 POTATO SHIPPING AREAS Week Ending March 16, 2019



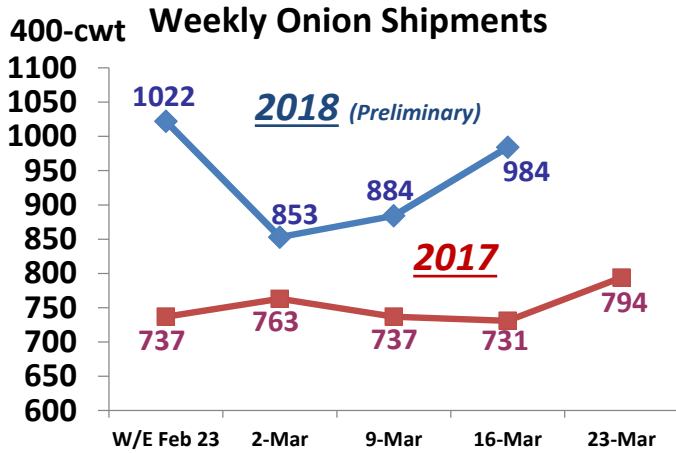

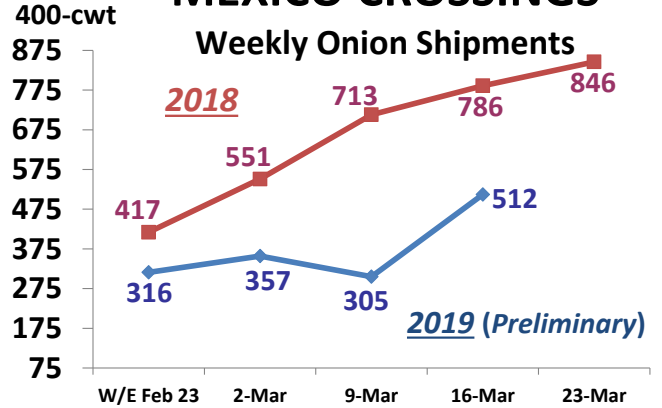

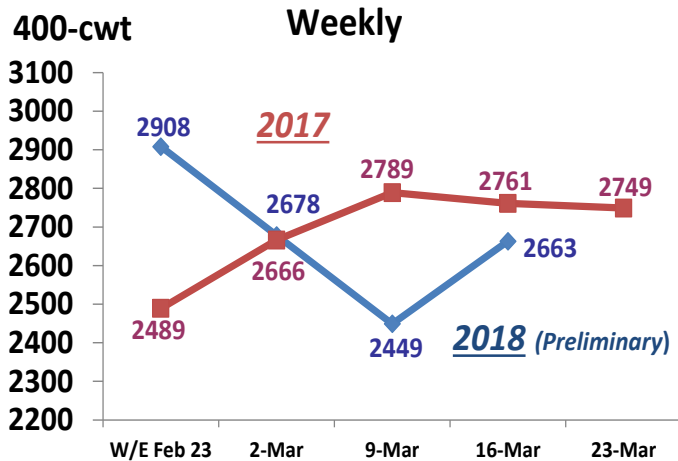

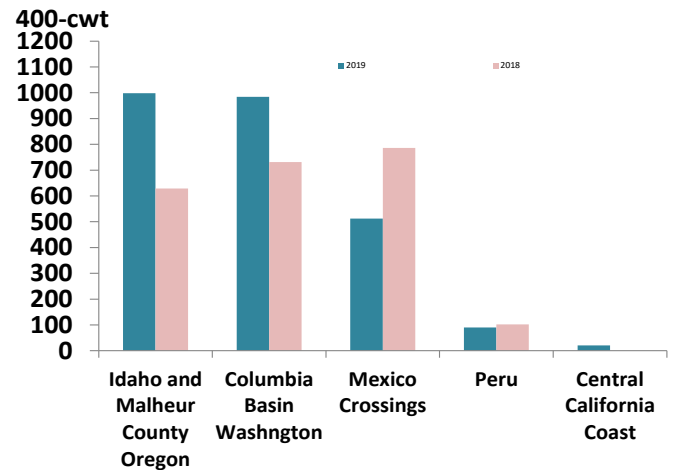
