Barnwell County requests that the Clerk of Court mark such easement to reflect the action of County Council in abandoning and cancelling this easement.



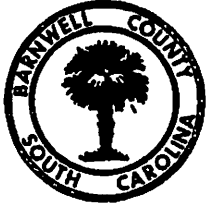
