**DUPR 29** (max aggregate 29.940)

\*Maximum individual player DUPR cannot exceed 4.99 to play in DUPR 29

**DUPR 26** (max aggregate 26.100)

\*Maximum individual player DUPR cannot exceed 4.35 to play in DUPR 26

**DUPR 23** (max aggregate 23.100)

\*Maximum individual player DUPR cannot exceed 3.85 to play in DUPR 23

**DUPR 20** (max aggregate 20.100)

\*Maximum individual player DUPR cannot exceed 3.35 to play in DUPR 20

\*in an effort to keep the divisions competitive, a max individual player rating has been added to the 2025 season. Ratings are based on when the individual signs up for the league.

DUPR 20: 3.000

DUPR 23: 3.500

DUPR 26: 4.000

DUPR 29: 4.500

The assigned NR ratings can only be altered with proper information submitted to the league organizer. The league organizer/program director reserves the right to make the final decision on a NR's assigned rating.

### **NR - NOT RATED PLAYERS**

If you are an NR player, your rating will be set to the average rating of the division you sign up for.

Example A: if you sign up for DUPR 20 you are assigned a 3.000 rating.

**Once a team registers for a Wicomico County Gender Double League, their ratings are “locked” and their DUPR increasing or decreasing will not impact the team’s aggregate or division placement throughout the season.**

**To sign up for the Wicomico County Gender Doubles League, a DUPR account is required at the time of registration.**

## **SUBSTITUTES/INJURY**

The Women's Pickleball League events:

If a replacement player that is already on the roster is made for an injured player during the event, the replacement player must remain in for the duration of the current game. A player that is replaced cannot be entered back into play until the next game.

If a team is unable to field all required players (2) for any reason before or during the match, then games will be forfeited with a score of 11-0.

If a player has an injury mid-game and cannot finish the game, and there is no replacement rostered player then the team forfeits that game. In this case, the forfeiting team will keep their score and the winning team will automatically be given a score of 15, or greater to ensure the game is won by two.

Forfeited games count for wins/losses and point percentage.

# **The Courts Team Men's Pickleball League Guidelines, Format and Rules**

## **League Format**

The Courts Gender Team Pickleball League is designed to provide a team pickleball competition while providing a fun atmosphere, where players can come and enjoy the company of not only their teammates, but also other players. The league will take place on Wednesday evenings at The Courts @ Harmon Field 409 Church Hill Ave Salisbury MD 21804.

### **The Teams:**

- Entry Fee for a full team is \$120
- All teams must consist of between 2 to 6 male players
- All teams will play a match consisting of 6 games vs. one opponent
- All matches will be played to 11 points win by 2.
- All teams must play all matches on the day listed on the schedule unless it is postponed by the program director to be rescheduled.
- All teams must play all matches with the players on their roster.
- **Teams will be allowed to make roster changes until JUNE 11, 2025.**
- **NO ADDITIONS ALLOWED after that date.**
- Matches may be played using any combination of your roster players.
- Team may choose to play all matches with the same two players or mix and match players/partners after each game until the match is completed.

### **The Season:**

The league will be scheduled to begin on Wednesday May 14, 2025

**Matches that are rained out will be made up at the end of the season**

Matches will be scheduled to begin at 6:00pm

All teams will play a balance schedule based on the number of teams in your division playing one match each week.

The Top half of each league will make a Championship Flight Playoff Bracket

The Bottom half of each league will make a Consolation Flight Playoff Bracket

## **Match Format**

The Courts Men's Pickleball League matches will use the following match format:

- teams will compete on a weekly basis
- The visiting team will get the first choice of side or serve for each match
- Each Match will consist of 6 games played to 11 points win by two
- IF A MATCH IS TIED 3 GAMES to 3 GAMES the following will take place.
  - A tie-breaker match will take place using rally scoring to 15
  - Teams will Freeze at 14 points and can only win the game while earning a point on the serve.
- All teams will call their own in/out and faults.
- A team may choose to play all games with the same 2 players or a team may choose to mix and match their rostered players after each game.
- **Substitute Players will NOT be allowed for this league.**
- **Teams not able to field 2 players for a match for that week, will be given a Forfeit LOSS. No Exceptions, games MUST be played on the day they are scheduled to be played.**
- Standings will be accumulated by wins and losses and posted at [www.quickscores.com/wicomico](http://www.quickscores.com/wicomico)
- Standings are based on a win loss record. If Team A defeats Team B 4-2 then Team A will get a win while Team B will get a loss.
