

**Traffic Commission Public Hearing
September 17, 2026**

Notice is hereby given in accordance with the provisions of Chapter 185 of the Acts of 1983, and Chapter 13 of the Acts of 1984, that the City of Revere Traffic Commission will conduct a Public Hearing on September 17, 2026 at 5:00 p.m. in the City Councillor Joseph A. Del Grosso Council Chambers of Revere City Hall relative to the following proposed amendments to the parking and traffic regulations of the City of Revere:

1. *Amend Chapter 10 Section 10.34.020 – Resident Parking Sticker:*

Vehicles registered to residents of an Accessory Dwelling Unit (ADU) shall not be eligible to receive a Resident Parking Sticker

2. *Amend Chapter 10 Section 10.34.020 – Resident Parking Sticker:*

Residential developments shall be included under Section 10.34.020 as Non-Eligible for Residential Parking Stickers:
