

Friend Referral Promotion

BCR is launching a Friend Referral Promotion for new clients. **New clients** and **Referrers** who meet the below terms and conditions (“Terms and Conditions”) will earn a Promotion Bonus from BCR.

Promotion Participation Terms and Conditions

- The Promotional Period (“Promotion”) shall run from 01 January 2019 to 31 January 2019. All clients participating in this Promotion must open the appropriate trading account with BCR and make their initial margin deposit within the above time frame.
- New trading accounts are funded via credit card are not eligible for this Promotion.
- The Promotion is only available to clients in jurisdictions where such Promotions are permitted by law.
- Opening a new trading account under the Promotion indicates that the client acknowledges that he has read and agrees to be bound by the Promotion Terms and Conditions, as well as by BCR’s Product Disclosure Statement (PDS) and Financial Services Guide (FSG). Clients must follow all account opening and trading requirements detailed by BCR.
- This Promotion is available to new direct clients only. It means that the new direct clients who has never registered to apply for a live trading account with BCR. The Promotion will be limited to one eligible participating trading account per client. Each client is only permitted to participate in the offer once, regardless of the number of trading accounts he maintains with BCR.
- The bonus for new clients is only valid after the new clients have fulfilled the trading requirements. New Clients must complete the trading requirements in order for the bonus portion to be eligible for withdrawal. An internal transfer account is not eligible for this particular promotion.
- The client must meet the requirements specified by BCR, deposit at minimum the required **initial** margin deposit, and complete the trading requirements.
- At the end of each month, BCR will check eligible accounts and the Referrer bonus will be credited to Referrer accounts.
- The referrer must not promote themselves representation of the BCR.
- BCR will not be responsible for any delays in receiving and crediting margin deposits to trading accounts caused by the processing times associated with using various payment providers.
- The client acknowledges that in the event he makes a withdrawal of margin related to this Promotion in violation of the withdrawal rules after he has earned his Referred Friend Bonus, BCR is entitled to deduct an amount equal to the Referred Friend Bonus earned.
- The client acknowledges that in the event that no transactions occur within 30 days of depositing the Promotion margin, BCR is entitled to automatically deduct an amount equal to the Referred Friend Bonus earned from his BCR trading account.
- The client acknowledges that in the event his trading account balance at any time becomes less than or equal to zero, or the trading account equity becomes less than Referred Friend Bonus earned, BCR is entitled to automatically deduct an amount equal to the Referred Friend Bonus from the client’s trading account. If the client’s trading account has open positions, the account will be set to “liquidation only”, and will no longer be able to open new positions. Once the client closes all open positions, BCR will deduct an amount equal to the Referred Friend Bonus.
- The client acknowledges in the event that any Referred Friend Bonus or equivalent value of received item is deducted from the client’s trading account because the client has failed to fulfill the requirements of the promotion, the client accepts that he or she has lost his or her eligibility in the promotion after the deduction is executed, and any bonus or received item or equivalent value of received item is permanently forfeited.

- Once the Friend Referral Bonus has been deposited into a Client's account, the Client is bound to follow the Terms and Conditions of the Promotion. The Client acknowledges that if he makes a withdrawal of any of the Promotion Margin (excluding Bonus deposits) before the Turnover requirements have been fulfilled, then Friend Referral Bonus shall be deducted immediately.
- In the event that it has a reason to suspect that a client has abused or attempted to abuse the Promotion or has used specific programs to cheat, or has otherwise acted with a lack of good faith, BCR reserves the right, at its sole discretion, to deny, withhold or withdraw from the client his eligibility to participate in the Promotion, and BCR is entitled to automatically deduct an amount equal to the stated value of the earned Promotional item from his BCR trading account.
- BCR reserves the right to modify, change or terminate this Promotion at any time, without the consent of the client. BCR also reserves the right to modify terms of this Promotion without notice.
