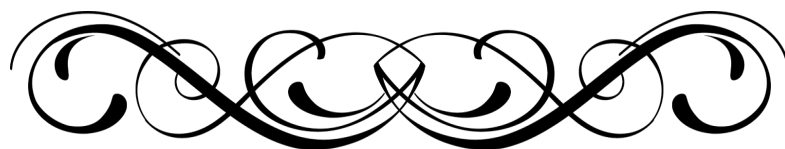

### **Carl's Dye-a-logue**

"Upon further review . . ." When professional sports leagues began to implement instant replay in their games, these words became much anticipated.

These words can begin a decision that will leave you either elated or devastated. They can lead to your team winning a "challenge" or losing.

Sometimes the official will say, "Upon further review the ruling on the field is confirmed." Sometimes they say, "Upon further review the play stands as called." "Confirmed" means they got it right the first time. "Stands" means they could not find indisputable evidence to change what was called.

If there was a mistake, the official will briefly explain and make whatever correction is necessary, based on there being indisputable evidence the ruling on the field was incorrect.

Regardless of the outcome, some people are going to be happy and some are going to be mad once the official says, "Upon further review . . ."

Not everything that happens in a game is "reviewable." Certain injustices will never be righted. Some "bad" calls will never be corrected. No matter how much whining and crying after the fact, the call was made, and it is final.

In Matthew 7:21-23 as a part of the Sermon on the Mount, Jesus tells us that on the Day of Judgment, there are some people wanting to challenge "the ruling on the field."

Many will hear their fate and say, "Lord, Lord, did we not prophesy in your name, and cast out demons in your name, and do many mighty works in your name?" In other words, Jesus, I want a review of what really happened.

Jesus, though will answer, "I never knew you; depart from me, you workers of lawlessness." In other words, Jesus will say, "After **NO** further review, the ruling is confirmed."

We only have one life, live it in such a way as to know that on the Day of Judgment, you are not one of those begging Him for a review.
