INSTANT REPLAY GUIDE

The Big 12 Conference received approval from the NCAA Football Rules Committee for the experimental use of instant replay for the 2005 football season. Instant Replay will be used for all conference games within the Big 12. It will also be available for non-conference games with the opponents' consent.

For the 2005 season, the Conference will use a version of replay similar to the experimental model employed by the Big Ten Conference last season with the following parameters:

- **Personnel** – Three people will be used and housed in a secured booth in the press box. They will consist of the replay official, alternate game official and technician.
- **Review Initiation** – This will be determined solely by the replay official. He will be assisted in the review by the alternate game official. The on-field referee may also be involved in the process through audio communication with the replay official and access to video review equipment on the sideline. A technician will assist in handling equipment and providing the actual replays for review.
- **Review Protocol** – The replay official will have until the ball is snapped to determine if the preceding play is reviewable. Five on-field game officials will be equipped with pagers, including the referee. These officials will be “buzzed” by the replay official to indicate a play is under review. The referee will then announce that play has been stopped for video review. The replay official will determine if there is **INDISPUTABLE VIDEO EVIDENCE** to overturn the call. After review of the available video evidence, he will communicate his decision to the referee for announcement and the resumption of play.
- **Equipment** – Technology developed by XOS will be used. All camera feeds used in the television broadcast production, or replay production in the case of non-televised games, will “feed” into the replay booth monitor. Each camera feed will be available to the replay official for review. The replay official will activate a particular camera angle for review of a play. If additional camera angles are needed to make a determination, they too may be activated.
- **Production** - All Conference games will utilize replay. The replay feed will be provided by the television broadcaster for all TV games. Those games not selected for telecast will be produced for replay purposes under an arrangement with FSN that will involve the use of a minimum of four cameras. Only non-conference games selected for telecast will be available for replay with the opponents' consent. The use of in-house video systems for non-conference, non-televised games will be evaluated on a case-by-case basis.
- **Training** – Big 12 Supervisor of Officials, Tim Millis, will coordinate the training of personnel in the use of replay. Millis will utilize at least two current NFL employees active in replay at NFL games in the training process. Fall practices and scrimmages will be utilized to test both equipment and personnel in preparation for the 2005 season.
- **Cost** – The estimated budget for the implementation of Instant Replay in the Big 12 is \$650,000 to \$700,000. This includes the purchase of all equipment, personnel costs and expenses associated with the production of non-televised games.

Under NCAA guidelines (as of June 20, 2005) the following plays are subject to review under Big 12 Instant Replay:

1. Plays governed by Sideline, Goal Line, End Zone and End Line

- a. Scoring Plays, including a runner breaking the goal line plane
- b. Pass complete/incomplete/intercepted at sideline, goal line, end zone and end line
- c. Runner/receiver in or out of bounds
- d. Recovery of loose ball in or out of bounds

2. Passing Plays

- a. Pass ruled complete/incomplete/intercepted in the field of play
- b. Touching of a forward pass by an ineligible receiver
- c. Touching of a forward pass by a defensive player
- d. Quarterback/Passer forward pass or fumble
- e. Illegal forward pass beyond the line of scrimmage
- f. Illegal forward pass after change of possession
- g. Forward or backward pass thrown from behind the line of scrimmage

3. Other Detectable Infractions

- a. Runner ruled not down by defensive contact
- b. Forward progress with respect to first down
- c. Touching of a kick
- d. Number of players on field

4. Timing

- a. Clock operation
- b. Play clock operation

The following are examples of plays that are NOT reviewable:

1. Holding
2. Off-sides
3. Pass interference
4. Personal fouls/late hits
5. Illegal blocks
6. Illegal formations
7. Face mask
8. Taunting/excessive celebration
9. False starts
10. Roughing pass/kicker
11. Fighting participants

In the anticipation of implementing replay for this season, Big 12 staff reviewed over 14,000 plays from games involving conference teams last season. Of those plays, it was determined that 36 were reviewable, and that of those 36, nine would have been overturned.

Tim Millis Supervisor of Football Officials

Tim Millis serves the Big 12 Conference as Coordinator of Football Officials with more than 30 years of officiating experience, including 13 in the National Football League.

Millis recently retired from the NFL having served 13 years as a field judge. His 13 playoff assignments as an NFL official included three championship games and Super Bowls XXIX and XXXIII.

Prior to joining the NFL, Millis officiated for nine years at the collegiate level, including five years with the Southwest Conference. His post-season bowl assignments included the All-American Bowl, Sugar Bowl, Fiesta Bowl and the Coca-Cola Bowl in Tokyo, Japan.

Millis officiated high school football in Mississippi, Florida and Texas. His high school service included numerous playoff games and two state championship games.

Millis graduated with a degree in accounting from Millsaps (Miss.) College in 1967. He and his wife, Dianne, have four children - Taz, Tim Jr., Tony and Tara. They also have seven grandchildren - Collin, Corbin, Peyton, Parker, Boone, Luke and Kate.

Did You Know?

Since the inception of the Big 12 nine years ago, 15 former conference officials have been selected for the NFL.

FOOTBALL SCHEDULING & CHAMPIONSHIP GAME INFORMATION

Scheduling: The Big 12 Conference is divided into two, six-team divisions in the sport of football. Each division will determine a champion based upon established criteria. All teams will play eight games as part of the Conference schedule — five games within the division and three games against teams in the other division. All games scheduled as part of conference competition count in determining the Conference record of each team. Rankings within the division will be determined on a winning percentage basis.

Divisional Champion: The (eligible) team with the best winning-percentage of all divisional members in its eight conference games is declared the divisional champion and representative to the Dr Pepper Big 12 Conference Football Championship Game. A team ineligible under NCAA or Big 12 rules for postseason (bowl) competition shall not compete in the Championship Game.

Divisional Tiebreakers: The following procedure will determine the representative from each division in the event of a tie:

- (a) If two teams are tied, the winner of the game between the two tied teams shall be the representative
- (b) If three or more teams are tied, steps 1 through 7 will be followed until a determination is made. If only two teams remain tied after any step, the winner of the game between the two tied teams shall be the representative.
 1. The records of the three teams will be compared against each other
 2. The records of the three teams will be compared within their division
 3. The records of the three teams will be compared against the next highest placed teams in their division in order of finish (4, 5 and 6)
 4. The records of the three teams will be compared against all common conference opponents;
 5. The highest ranked team in the first Bowl Championship Series Poll following the completion of Big 12 regular season conference play shall be the representative
 6. The team with the best overall winning percentage [excluding exempted games] shall be the representative
 7. The representative will be chosen by draw.

COMMISSIONER KEVIN WEIBERG

The 2005-06 athletic season marks the eighth year the Big 12 Conference has been led by Commissioner Kevin Weiberg. Under his direction the Big 12 has continued to be regarded as one of the nation's premier conferences, with an unwavering dedication to success both on and off the field.

Weiberg continues to play a prominent role nationally in collegiate athletics. He supported the academic reform effort that introduced Academic Progress Reports for NCAA member institutions and the approval of 12-game regular seasons in I-A football. He has also previously served a three-year term on the NCAA Division I Men's Basketball Committee and completed a two-year tenure as chair of the Division I-A Collegiate Commissioners' Association.

This season marks his second and final as coordinator of the Bowl Championship Series. As BCS coordinator Weiberg led the negotiation of a new four-year television contract with Fox Sports for the rights to Bowl Championship Series games, exclusive of the Rose Bowl, through the 2009 season. His term as coordinator has also seen the implementation of qualification standards for conferences, greater access for conferences and teams previously outside the system, renewed contracts with the BCS bowls, the realization of a simplified standings formula, the advent of a college football Top 25 poll, and introduction of transparency into the voting process.

This past spring he announced enhancements in regulatory spending by the Conference, introducing an expanded drug testing program to include a wider array of performance enhancing drugs; a three-year cycle of compliance audits by an outside firm of member institution's athletic departments; and a gambling awareness initiative.

Weiberg is working with the Conference's Board of Directors in establishing an economic development consortium to provide benefits to member institutions beyond intercollegiate athletics. He will also be focused on arranging the next round of bowl agreements for the league, future hosting sites for the Big 12 football, basketball and baseball championships, and television negotiations.

Since being named the second commissioner in Big 12 history on October 8, 1998, and officially assuming the post December 4, 1998, a total of 21 NCAA championships have been won by conference teams with nearly 200 individual national titles to the league's credit. The conference has had an unprecedented eight men's and women's basketball teams advance to their respective Final Fours in the past four seasons, highlighted by Baylor's women's basketball National Championship in 2004-05. The Big 12 also has sent 10 teams to BCS bowls in the seven-year history of the system, with four appearances in the National Championship game since 2000. The league's success continued in 2004-05, with NCAA team championships in women's cross country, men's cross country, wrestling, women's basketball, women's outdoor track & field and baseball. In fact, Weiberg has seen



at least one team win a national title every season since being named Commissioner.

During his tenure, the Big 12 has also implemented a firm fiscal policy and continues to explore avenues to expand revenues. For the 2004-05 fiscal year, the Big 12 distributed a record \$105.6 million to its member institutions. Since beginning operations nine years ago, the Conference has nearly doubled its first allocation of \$54 million established during its inaugural year.

In January, 2005, the Board of Directors announced the four-year extension of Weiberg's contract through 2010, with a four-year option to 2014.

Prior to joining the Big 12 Conference, Weiberg worked in conference operations for almost 10 years at the Big Ten Conference, beginning as Associate Commissioner/Chief Operations Officer before being promoted to Deputy Commissioner.

His professional career began with a 1979-80 post as Sports Information Director at Wayne State (Neb.) College. Weiberg moved to Wichita State University from 1980-87. He was Sports Information Director at WSU from 1980-83, Assistant Athletics Director for Marketing/Fund Raising from 1983-86, and became Associate Director of Athletics in 1986-87. Weiberg then served as Associate Director of Athletics at the University of Maryland from 1987-89.

The Anthony, Kan., native earned a Bachelor of Science degree in Education from Kansas State University in 1978 and Master of Science degree in Athletics Administration from Western Illinois University in 1979.

Born July 7, 1956, Weiberg is married to the former Susan K. Latta. The couple has three children - Erika (19), Jenna (16) and Garrett (14).
