BIG 12 CONFERENCE CONCLUDES SPRING MEETINGS

Colorado Springs - The Big 12 Conference concluded its annual spring meetings today at the Broadmoor. The session was conducted with the full Joint Council consisting of faculty athletic representatives, athletics directors and senior woman administrators representing each of the member institutions.

Actions included the approval of enhanced spending in regulatory areas. The council approved the use of an outside agency to conduct compliance audits of member athletic departments. Each institution would be audited once in a three-year cycle for a thorough review of compliance systems to include student-athlete recruitment, academic support and enforcement policies.

The Conference also announced the expansion of its drug testing program for performance enhancing drugs by increasing the number of random tests administered to student-athletes and the types of substances tested for. A gambling prevention program was also approved.

"The Joint Council approved an additional \$150,000 total to be spent on these three programs," said commissioner Kevin Weiberg. "This measure allows us to take a proactive approach in each of these areas."

The commissioner also announced the approval of funding for Instant Replay and that the Conference anticipates distributing a record \$105.6 million to the membership for this fiscal year.
