Big 12 Commissioner Dan Beebe:

On Cost-Containment.....

"We touched on cost-containment, but is something our Athletics Directors have been tracking for a while. One result of those discussions was our football and basketball coaches not meeting in Colorado Springs. We will talk more about it in our Joint Council meeting. The future of our in-person meetings is part of that discussion."

On the Big 12 Bowl Relationships.....

"We are blessed and fortunate to have so many great bowls and cities that are interested in us. We're in a great situation."

"I don't think we will have much change in our bowl partners, just possibly in the order of selection."

On changes to the Bowl Championship Series.....

"We went through the exercise last year as part of the new contract. It is our feeling that we did this and there should not be an adjustment to it in the four-cycle that was agreed upon."

Missouri Director of Athletics Mike Alden:

On football officiating.....

"Officials are evaluated on a regular basis. It is done in a very timely manner. There is significant support for Walt Anderson (Coordinator of Football Officials) and the Big 12 officiating program."

On the Bowl Championship Series

"We are committed to the system"
