Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Other - Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	Springboard Communications is a Public Relations (PR) and communications agency. The company has had clients in the Fossil-Fuel (non coal/oil-sand) and Pharmaceutical industries which are deemed controversial by B Lab. The services provided to the clients relate to strengthening internal and external communications. The services provided to the clients can be sold to other clients in different industries, including other both non-controversial and controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year end of 2023, the company had generated 5% of its total revenue from clients in the fossil-fuel industry and 10% from clients in the pharmaceutical industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Springboard Communications has introduced a client screening policy and reviews all potential clients against its mission, values, and sustainability policy. If any risks or potential misalignment are identified at the initial evaluation stage, it is escalated to the company's Senior Leadership team for discussion and decision. The company is part of Purpose Disruptors, a voluntary organisation whose mission is to help the communications industry tackle climate change. Since joining the organisation, Springboard Communications has amended its business

	briefing documents to ensure sustainability strategy and policies are included as part of its due diligence process. Springboard Communications has refused to work with potential clients in other industries deemed controversial such as tobacco and gambling.
Management Comments	Springboard Communications emphasizes that they work with clients who are leading the green transition in Ireland through onshore, off-shore wind energy and solar technology. In order for Ireland to meet its 2030 Climate Action targets, the company claims these organisations are a critical part of the eco system and they align with its mission and purpose.
