TOPIC	Other disclosures - rat spotted on a Pieminister restaurant site
SUMMARY OF ISSUE	Pieminister is a company that sells food products and manufactures the majority of products (99%) in-house. In May 2022, a rat was spotted inside the entrance of Pieminister's Leeds restaurant. A video recording of the event was posted on social media by a former worker, who was the first Pieminister staff to know about the issue. The probable cause of the event was major roadworks in front of the restaurant around that time, causing disturbance to groundworks. It was an isolated event and the company conducted proper remediation actions immediately.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In an isolated event, one rat was found on the restaurant premises. There were no reported health-related issues.
IMPACT ON STAKEHOLDERS	The presence of rodents poses a risk to people's health and the cleanliness of the environment. As a restaurant and food manufacturer, the company needs to have practices in place that guarantee food safety and proper hygiene for employees and clients.
IMPLEMENTED MGT PRACTICES	As soon as the video was posted, Pieminister called pest control who visited immediately. They found no sign of rodent activity anywhere in the building. On the request of Pieminister, the site was deep-cleaned twice. The restaurant was signed off as pest free. The pest control visits Pieminister's restaurants eight times a year as part of its contract with the company. Leed City Council EHO also inspected the site. They produced documentation to confirm that the company conducted appropriate remediation actions. Pieminister continues to hold a 5 Star EHO rating for food & hygiene standards in the restaurant.
MANAGEMENT COMMENTS	Pieminister is a Grade A BRC accredited food producer — which means they hold the highest rating in terms of food safety and hygiene.
