

## **DISCLOSURE MATERIALS**

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company is a renewable energy provider and also sells natural gas to its clients
SUMMARY OF ISSUE	"Holaluz is a Spanish renewable energy provider. The company's main focus is on renewable energy supply and solar panel installation. Holaluz also sells natural gas, in response to requests from their customers. The company offers gas commercialization to its own clients or to those who have contracted the electricity supply with a 100% renewable commercialization company. Emissions related to gas commercialization are offset annually through renewable energy projects in different countries.  Because Holaluz was a certified B Corp when B Lab published the Fossil Fuels statement, the company has one full recertification cycle to meet the Fossil Fuels industry standards. For the current recertification, Holaluz has shared strategic plans to meet the Fossil Fuels industry standards by their next recertification."
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Gas represents 5% Sales (Net Value of Turnover).
IMPACT ON STAKEHOLDERS	Fossil fuel and energy companies, including natural gas sellers, are recognized by B Lab as controversial industries due to their significant impact on global greenhouse gas emissions and the current climate emergency. IMPLEMENTED MGT PRACTICES	"The company offsets its carbon footprint associated with the sale of natural gas by purchasing carbon credits from renewable energy projects. At the beginning of the year, the company makes an estimate of gas consumption during the year is made and the carbon credits corresponding to this estimate are purchased. The purchase of these credits is not verified by an independent company.
	Currently the company has started an project (2021-2022) with external specialists support where it is going to disclosure its net zero commitment before 2040, calculate and disclosure GHG emissions scope 1,2,3, from 2021 period, establish reduction targets (validated with sbti organization) and design naturalization emisions strategy.
