- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	In collaboration with external partners, Winclove Probiotics is involved in studies that include animal testing experiments.
SUMMARY OF ISSUE	Winclove Probiotics is committed to ensuring the welfare of animals used in research & development, and considers the use of animals to be ethically appropriate only when no alternative methods are available, or when the use is mandated by legal or regulatory requirements.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	On average, <5% of the studies conducted per year are animal studies and this percentage has been stable over the past years. Due the lack of non-animal alternatives for some type of studies, it is foreseen that the percentage of animal studies performed by Winclove Probiotics will remain stable in the coming years.
IMPACT ON STAKEHOLDER(S)	Animal experiments are widely used in food & drug research to evaluate the quality, safety and efficacy of new products. Many of these experiments can result in suffering to the animals involved or reduce their quality of life in other ways.
IMPLEMENTED MGT PRACTICES	Winclove Probiotics is committed to ensuring the welfare of animals used in research & development, and considers the use of animals to be ethically appropriate only when no alternative methods are available, or when the use is mandated by legal or regulatory requirements. Winclove Probiotics is committed to developing and implementing non-animal methods and clinical research studies instead of animal studies whenever possible. As result of that policy, the percentage of animal studies in which Winclove Probiotics is actively involved, is low compared to the percentage of non-animal studies (incl. in vitro and human clinical trials). For research involving animals, Winclove Probiotics fully adheres to the 3Rs: Replacement, Reduction and Refinement of animal use in research & development. Based on those principles, Winclove Probiotics only authorizes animal use when a non-animal method is unsuited for the required use (replacement), the number of animals used is kept to a minimum (reduction), and practices are implemented to promote animal welfare and prevent animal pain and distress in housing and procedure conditions as much as possible in an experimental research setting (refinement). Moreover, Winclove Probiotics authorizes animal use only when the regulatory and scientific merit is established and the experiments are performed under strict ethical oversight by a local or national animal ethical and welfare committee. In addition, Winclove Probiotics actively invests in research projects to aim to develop alternatives to animal experiments



OTHER MANAGEMENT COMMENTS

Winclove Probiotics is morally and legally obligated to ensure the quality, safety and efficacy of its products. Winclove Probiotics acknowledges that in some

cases animal testing is inevitable in its research & development processes to ensure the quality, safety and efficacy of its ingredients and finished products.

Therefore the responsible use of animals remains a small but an integral part of a comprehensive research and testing strategy. Animals are living, thus sentient creatures, which obviously have intrinsic value and Winclove Probiotics is of the opinion this must be deeply respected. In addition, the ethical concerns of the general public regarding the use of animals in research, must be respected as well. However, the worldwide scientific community agrees that, despite that it is desirable to replace the use of animals in research & development processes by other methods, the use of animals continues to be necessary to protect human and animal health. For this reason, animal testing is performed only when non-animal alternatives are unavailable
