

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	August 2020
TOPIC	Significant layoffs due to COVID-19 and UK lockdown.
SUMMARY OF ISSUE	Because of COVID-19 and UK lockdown the company had to layoff some of its employees.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Due to temporary and permanent closure of retail stores, cruise ship spas and landbased spas due to Covid pandemic, 171 employees were laid off, representing 35% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	The company provided the Employee Assistance Programme (EAP) to support employees during their consultation periods (the period of time during which an employer must carry out meaningful consultation with employees who are at risk of redundancy or affected by it) The company retained contact details of employees affected by redundancies and sent them vacancies for 6 months after the leave date The company allowed the product discount to former employees for a short period of time
