



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Significant layoffs due to COVID-19
SUMMARY OF ISSUE	Cubitts had 95 employees in Q1 2020. Due to the prolonged Covid-19 pandemic, the company was forced to make redundant 21 roles (23.5% of total workforce) between March and October 2020.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	21 employees were laid off, representing [23.5%] of the company's employees at that time. <ul style="list-style-type: none">• March 2020, 18 employees (19% of total headcount)• October 2020, 3 employees (4.5% of total headcount)
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	Cubitts provided severance pay and access to post-employment coaching sessions for all employees who were laid off due to the Covid-19 pandemic. These employees were also allowed to keep the company IT equipment.
MANAGEMENT COMMENTS	Every effort was made to redeploy roles into other areas of the business that were able to keep running during covid, inevitably that wasn't the case for all. The decisions to lay off employees in March 2020 was made prior to any knowledge of the furlough scheme becoming available. During our recovery from Covid from March 2021 onwards, every effort was made to re-employ those who had previously lost their job. Katie Dolby - Cubitts Retail Director.
