SUMMARY OF ISSUE	As a recycling and waste management provider, First Mile Limited operates in an industry in which energy and carbon emissions is a material environmental issue.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 100% of First Mile Limited's revenue comes from recycling and waste management services.
IMPACT ON STAKEHOLDERS	As an energy intensive industry, waste collection and incineration is a contributor to global carbon emissions.
IMPLEMENTED MGT PRACTICES	First Mile Limited complies with all relevant legislation and regulation to ensure best possible environmental practice and compliance. They are currently certified under ISO 14001 and their vehicles meet Euro 6 Vehicle emission standards, at present, the highest standard outlined by the European Union. The company has rolled out a fleet of zero-emission cargo bikes which make collections and consolidate recycling in built up areas so that their trucks can reduce road miles and be more efficient, this reduces the emissions per tonne of waste collected i.e. CO2 and NOx from vehicles. The company uses software to optimize the routing of delivery and waste collection routes to reduce the distance traveled by its vehicles, and to reduce the number of vehicles required. Additionally, the company also deploys telematics to measure their driver's driving style to reduce inefficient driving and unnecessary idling. To further emphasize this practice, drivers that are more energy efficient are rewarded with a bonus. With respect to scope 3 emissions from the purchasing of services from waste processors - the company diligence their suppliers to ensure best environmental practices are followed relating to incineration, and promotes local markets ahead of transfrontier shipments for recycling. Additionally, the company has switched to fully renewable energy across all its locations and are implementing energy saving measures such as low energy appliances and remote control of heating via mobile app with programmable modes for different room types within their premises.
