- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process

Topic	Clients in Controversial Industries
Summary of Issue	Equi Media Ltd is a digital media and marketing agency.
	The company has had clients in the Charity Lotteries and For-Profit Higher Education industries which are deemed controversial by B Lab. The services provided to the clients relate to website design, build & maintenance and Search Engine Optimisation (SEO).
	The services and products provided to the clients can be sold to other clients in different industries, including other both non-controversial and controversial industries, although it is tailored from client/industry to client/industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year end of 2023, the company had generated 0.58% of total revenue from clients in the charity lotteries, and 1.18% of total revenue from clients in the for-profit higher education industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Equi Media does not currently have a formal position on working with clients in controversial industries. However the company operates based on a policy of not working with organizations that cause harm in any way.
	In deciding to work with potential clients, the company would first look into what the client organization does, and how the potential client affects the environment or society. Equi Media would perform a research on the potential client organization



	before committing to engaging them and politely decline to provide services to potential clients which they believe may not be responsible or beneficial to the society.
Management Comments	When taking on new clients we carefully assess their impact on society and the environment and weigh up any issues against their overall contribution.
	We selected to work with our higher education institution as they specifically work to educate the next generation in sustainability and environmental management. We assessed that the charity we helped create a lottery for provide a vital service to all of society in one area of the UK and view their contribution as invaluable.
	We commit to formalizing our evaluation process and applying the same rigor to any organization that wishes to work with us."
