Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Facilities located in sensitive ecosystems

Topic	Company has a hotel located beside Monte Peglia Biosphere Reserve, Italy.
Summary of Issue	The company has a hotel beside a nature reserve in Italy, classified by Unesco as Monte Peglia Biosphere Reserve. The 4000 hectares nature reserve consists of an extensive forested area and constitutes an important natural pool of fauna, flora and mushroom species in and around this ancient extinct volcano.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	100% of the land owned by the company (60 hectares) is adjacent to the Monte Peglia Unesco World Biosphere Reserve. The Hotel is built within the land the company owns.
Impact on Stakeholders	Potential risks from operations located in sensitive ecosystems include damage to local environments from human and mechanical impacts, as well as indirect impacts from land conversion use and risks to flora and fauna.
Implemented Management Practices	The property was built upon a derelict house in Italy's Umbria region and places sustainability on top of its priority list. • The building has thermal insulation (A4) so the power needs are minimum. • Solar panels produce more than 100% of the energy and heating needs without any combustion. • The cooling system in the summer is totally operated by solar energy. • All products used in the hotel are biodegradable and plastic free, and the Hotel is completely vegetarian. • All waste are differentiated, or composted or collected by the local company in charge of recycling. • The company has electric vehicles for transportation • All the water from the rain is used to irrigate the garden. The company has constantly communicated to its stakeholders on their webpage and on social media on multiple occasions that the Hotel Eremito is located adjacent to the Unesco Natural Reserve of Monte Peglia.
