- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	2019
TOPIC	Required animal testing by regulatory authorities
SUMMARY OF ISSUE	The company was required to undergo animal testing for a new product 'azul de jagua (jagua blue)' by the FDA to guarantee food safety standards. The company states that there were no alternatives to animal testing possible at the time.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	As a food and cosmetics company that develops new products, they may be required to undergo animal testing for products again in the future.
IMPACT ON STAKEHOLDERS	Animal testing can cause pain and suffering to animals. Experts recommend evaluating whether the Three R's (Reduction, Replacement and Refinement) can be applied to alleviate unnecessary suffering.
RESOLUTION	The company hired a specialised and certified laboratory to carry out the animal testing. The company had their own code of ethics.
IMPLEMENTED MGT PRACTICES	The criteria for selecting a laboratory are: 1. The lab had experience with the test. 2. The lab have GLP certification. 3. The FDA approved the protocol before conducting it. The company has only worked with one laboratory in toxicity studies. The company does not have an animal testing policy.
