TOPIC	Company serves a client in the extractives sector (fossil fuel extraction).
SUMMARY OF ISSUE	As a training company, Mission Performance Limited provides leadership trainings to a client that is an oil field services company. The company services are provided to the health & safety team as well as the sales and commercial divisions. The company provides communication and coaching support across the range of services (energy - water - environmental) for the Sales and Commercials team. For the Operations team, the company provides Human Factors training, specifically on how to make operations safer through the minimization of risk.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Company derived ~39% of their annual revenue from the client in the extractives sector in 2020.
IMPACT ON STAKEHOLDERS	The impact of extractive operations would be with the communities and the ecosystems where the company's clients are situated, should their control & risk management systems fail and result in some negative social and environmental impact.
IMPLEMENTED MGT PRACTICES	Company has previously turned down contracts in certain parts of the world and continue to exercise discretion in this area. For the extractive industries above, they work across their full portfolio and not solely on Fossil Fuel extraction. Company also reviews all potential new client relationships and makes informed decisions based upon the client's track record and future strategies. Company also conducts research into each organization before formally engaging to work with them. There is constant monitoring and development in this part of the company's business.
