Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	<p>New Hope Ecotech Negócios Empresariais e Gestão Social Ltda (Eureciclo)'s parent company (NH Ecotech LLC) is registered in Delaware and its parent's parent company (New Hope Ecotech) is based in the Cayman Islands. All Eureciclo staff and operations are based in Brazil.</p> <p>New Hope Ecotech is the international holding structure that consolidates Eureciclo's operations. The Cayman and Delaware entities were established to attract international impact investors and to facilitate transparent investment flows into the Brazilian operating company, New Hope Ecotech Negócios Sociais e Gestão Empresarial Ltda. All operational activities, employees, and clients are based in Brazil. The offshore entities serve exclusively for governance, investment, and financing purposes, not for tax reduction.</p>
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In 2023, as the company reported no profit, there is no Corporate Income Tax (IRPJ) to be paid. The company pays an overall tax rate of 14%.
Impact on Stakeholder(s)	In addition to the many different aspects of value that business provides society, business has an obligation to contribute its share of taxes. This is because business exists within the context of society; its proper role is to serve society, not the other way around. Moreover, healthy businesses can only exist over the long term in a healthy society. A healthy society depends upon public expenditures made possible by taxes.
Implemented Management Practices	<p>The company shared the following practices:</p> <ul style="list-style-type: none">- All sales made in Brazil are reported through New Hope Ecotech Negócios Empresariais e Gestão Social Ltda and taxed according to the Brazilian Legislation,- The company conducts full tax and financial reporting in Brazil,- All transfer-pricing rules and tax obligations are complied with,- Annual independent audits and disclosure of financial statements,- Governance policies aligned with B Lab's tax philosophy: commitment to transparency, fairness, and payment of taxes
