

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Smart Mining is a company that offers resource efficiency solutions through their technological platforms to companies in the mining industry.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company is a startup that has been operating since 2018 and been working with mining companies since their pilot phase to test the technology at one of their processing plants. Currently 100% of their revenue in 2021 is coming from mining industry
IMPACT ON STAKEHOLDERS	The mining industry is a necessary industry to provide mined minerals for industrial production, however, there can be risk related to workforce, human rights abuses, environmental impacts and community impacts.
IMPLEMENTED MGT PRACTICES	The company offers a process monitoring service, mainly in the milling stage, which allows obtaining data on the behavior of this process to generate efficiency, operational control, and savings of critical inputs: water, electricity, steel). They aim to contribute to the saving of critical resources and therefore to the conservation of resources. Their product is not related to compliance with legislation.
	The service is designed to be implemented in various industries, where it is possible to install sensors and perform process monitoring, always with a view to overall operational control and process efficiency, for resource conservation.
	The company position is to help an industry such as mining to reduce its environmental impact by contributing to the conservation of resources.
	They do not have a due diligence process in place.
