Topic	Company serves clients in Controversial Industries
Summary of Issue	Bemari is a company that provides sustainability consultancy to clients in controversial industries such as the mining industry in the region of Limpopo Province (South Africa). 1. The services support companies with managing harm (e.g. environmental management system, stakeholder engagement management) as well as compliance with the standards e.g. ISO and ICCM standards, permitting requirements. 2. The same product can be and is sold to clients outside of mining - it is our knowledge of the mining sector that helps us tailor the service, but the nature of the solution is not specific to the sector.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	8.9% of the client revenue has been from clients in the mining industry in 2022. 1. We charge mining in the same way as other sectors - based on time, materials, standard charge out rates. 2. We have worked with 3 mining clients and have delivered 5 projects over the last 5 years.
Impact on Stakeholders	Companies that offer products/services to clients in controversial industries may be contributing to the controversial impact of those industries.
Implemented Management Practices	• The mining clients we work with tend to be very large so the ESG information is available in the public domain. We review this information, but given our service to them focuses on improving their ESG performance, we do not filter them out if their scores are not very high (which generally they are high). • We will not work with tobacco, arms/ defense, animal testing or any other companies whose products or

	services are inherently not serving a need at this point. • We have not set ESG targets in relation to work with these industries, we just do not wish to support organizations that do not align to our values.
