

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	<p>"Impact Hub Taipei is a sustainability consultancy that has had a client in the tobacco industry over the last 4 years. The company offers sustainability embedded solutions and employment empowerment solutions to support companies in delivering sustainability/SDG related projects and programs. Impact Hub Taipei offers the same service to other corporate clients, adapting to their needs and multinational clients are charged a flat rate.</p> <p>For the client in the tobacco industry, the company supports the design and implementation of the customer's annual volunteer training camp, annual company-wide sustainability week, capacity building for their supporting beneficiaries (arts, elderly care and disability focused nonprofit organisations). Impact Hub Taipei are not involved in the production, operation, trade or sale of tobacco."</p>
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year 5% of the company's revenue was from a tobacco company.
IMPACT ON STAKEHOLDERS	<p>"Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.</p> <p>B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter."</p>
IMPLEMENTED MGT PRACTICES	Impact Hub Taipei does not currently have a position on working with clients in sensitive industries nor has implemented efforts to move away from potentially sensitive industries. The company spends months evaluating their clients/customers on their commitment to sustainability through regular check-in meetings or informal talks with the sustainability/ESG managers before kicking off any collaboration. The company mentions that if their clients' ideas are more on one-time event or not clear with a long term strategy, then they don't onboard them as their clients/customers. The company also checks on the client's previous projects and initiatives to see if it they stick to the company's core capacity and sustainability focus.
