



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Industries At Risk of Human Rights Violation
TOPIC	Mothership Holdings Limited is a milk chocolate manufacturer and sources over 25% of their raw material expenses from cocoa products.
SUMMARY OF ISSUE	The company sources chocolate using its Impact Trade Policy from a Colombian partner who working with cacao farmers across the country. All cocoa suppliers are based in Colombia.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	95% of the company's revenues come chocolate made from cocoa beans
IMPACT ON STAKEHOLDERS	The global cocoa industry has a history of forced and child labor, which subjects workers to poor working conditions, low wages, and puts children at risk for human trafficking.
IMPLEMENTED MGT PRACTICES	Part of the company's supply chain is assessed by slavefreetrade, a Swiss human rights NGO. A large majority of cocoa beans can be traced back to the co-operatives and the region for the country.
