



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Significant Layoffs
SUMMARY OF ISSUE	Due to financial reasons, the company decided to close down all 3 Designers Remix retail stores and focus only on wholesale and e-commerce.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company laid off 8 full-time employees and 20 student workers. These numbers represented 100% of its retail staff and 27% of its HQ staff. All personnel was informed of the layoff date on August 31 2018. The stores were operational until January 31 2020 due to lease termination, most employees stayed on board until this date.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	- For the headquarters' layoffs, all employees received a 3 to 6 months termination notice. These former workers were able to find another job right after leaving the company, - Regarding the workers laid off from the retail stores, all of them received a 4 months termination notice.
RELATED INCIDENTS (YES/NO)	Designers Remix has not had any other layoff in the last 5 years. The only layoff happened at January 31, 2020.
