



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Clients in Controversial Industries
SUMMARY OF ISSUE	The company works with some companies in controversial industries. Air is a creative agency and the services they provide to the clients in the controversial industries are also available to other clients. The rates charged are the same in controversial and non controversial industries.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Fossil Fuel Industry represents 13% of their total revenue for FY21.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
IMPLEMENTED MGT PRACTICES	Air has one single client in the fossil fuel industry. The services they offer to this client are related to a single product (lubricants) and limited to pre-press for labels (translating and adapting formulas for labels on industrial lubricant's packagings and send them for printing) and IT for intranet (designing and uploading informative content for the client below the line activities). In more recent years, Air claims to have tried to accompany their client in their Sustainable transition. Air believes that companies in these types of industries need to be supported in order to accelerate towards the carbon reduction targets or carbon neutrality goals they have set for themselves. Air is working to propose real solutions to change some of the environmental aspects they can control in their work for their client in fossil fuels. Air is raising awareness and education through workshops and the constant proposal of improvements for the benefit of the planet for their client. Air claims to verify new clients' ESG compliance by conducting online desk research on client's track records. They investigate sustainability reports and best efforts, and question clients on key related matters before moving on with them. Fossil fuel is the only controversial industry that Air has offered their services to. They refuse to work for some sensitive industries, such as tobacco or gambling, mining industries, among others.
MANAGEMENT COMMENTS	The collaboration with their client in fossil fuel has historical reasons. They inherited this business in an agency acquisition in 2014. They took over the whole senior staff with a long job tenure.
