

## DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

<b>DISCLOSURE QUESTIONNAIRE CATEGORY</b>	Significant layoffs of >20% of workforce
<b>ISSUE DATE</b>	August/1/2019
<b>TOPIC</b>	Significant layoffs due to ceasing development of Mobile Mesh Networking product in Canadian office. Project development was moved to our Bangladesh offices to work more closely with first project with Rohingya refugee camp in Bangladesh.
<b>SUMMARY OF ISSUE</b>	Left restructured an aspect of their business offerings, based out of its Maple Ridge office in Canada resulting in layoffs of the software development project team. Restructuring included mesh technologies moving closer to the customer (Bangladesh) and the Canadian team prioritized through developing a travel with purpose platform.
<b>SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)</b>	19 employees were laid off, representing ~40% of the company's employees at that time.
<b>IMPACT ON STAKEHOLDER(S)</b>	Employees were given a severance package over and above the minimum Employment Standards amount. Company activated network to try to help affected employees find new employment.
<b>IMPLEMENTED MGT PRACTICES</b>	Severance pay, assistance with finding new employment, network connections, offer of resume reviews, reference letters. Layoffs occurred on Aug. 2nd and extended health and dental benefits were continued until Aug. 31st for all employees.
<b>OTHER MANAGEMENT COMMENTS</b>	All employees were offered time to sit 1:1 with co-founders and HR to explain layoff, answer any questions, and offer assistance. Left has since directly tied its headcount workforce growth plans to its earnings.
