



## DISCLOSURE MATERIALS

North South Wines therefore is required to have approval from the Alcohol Wholesaler Registration Scheme (AWRS). North South Wines AWRS certification is attached.</p> <p>North South Wines has a partner London City Bond, a 3rd party Warehousing and Distribution company that specialises in the handling of Alcohol and operate a bonded warehouse LCB provide confirmation to North South Wines in their signing of the code of conduct that they comply with all associated legislation.</p> <p>LCB have provided North South Wines with their licence permitting them to store bonded goods at the Linton site they operate from. LCB have provided North South Wines with their licence permitting them to sell by retail alcohol from the Linton site they operate from.</p> <p>North South Wines are involved in the arrangement of the sale of alcohol to businesses that onward retail it. Employees are not involved in the selling of alcohol to individuals. Despite this we have ensured at any point in time at least one of our staff have had the training for and hold a personal alcohol license just in case a requirement materialises.</p> <p>The risk of selling to minors is entirely mitigate by North South Wines not selling to members of the public.</p> |
