Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Strengthscope Limited is a consulting firm focused on providing solutions to corporate clients in the area of Leadership Development, Team Development, Talent Acquisition & Recruitment, Employee Engagement & Wellbeing, Change Management, Diversity & Inclusion and Early Careers. The company has had clients from the Fossil-fuel (coal/oil sands) and Pharmaceutical industries, which are deemed controversial industries by B Lab. All of the company's services can be sold to both controversial as well as non-controversial industries, although it is tailored from client/industry to client/industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year end of 2023, the company had generated 0.87% of its total revenue from clients in the fossil-fuel industry. The last service provided to clients in the pharmaceutical industry was in the year of 2022 and the company earned 1.17% of its total revenue from the industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Strengthscope does not have a specific formalized policy on working with clients in controversial industries. However, the company is currently minimising its exposure in sensitive industries and is working towards reducing this over time. Strengthscope reviews the level of harm created by the companies they work with on an annual basis in order to

	minimise its exposure to sensitive industries. In order to limit any potential level of harm at present, Strengthscope reviews information provided by clients/potential clients on their website and during further discussions with clients/potential clients on what they themselves are doing to limit harm and to operate ethically. The information gathered through the background research and discussions provides the Board with insights to each client's/potential client's 'direction of travel' and whether they are making efforts to move towards ethical working practices, or whether they currently adopt ethical working practices. Strengthscope's Board is able to openly discuss any concerns about clients/potential clients who are operating in sensitive industries and are able to make a collective decision on whether they would go forward with these organisations as clients in future.

Strengthscope Limited has an employee(s) under Zero Hour Contract which allows the employer to vary the working hours of an employee, with no guarantee of employee hours, while the employee is required to be on call.
