- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process

Issue Date	2021 and 2025
Topic	Litigation related to Automobile Accident and Personal Injury
Summary of Issue	Litigations against the company involve a lawsuit filed by a private individual concerning a vehicle accident by an employee, hitting the back of their vehicle, and another by a pedestrian concerning a personal injury on a roadway we maintained for the county.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The total value of litigations related to automobile accidents and personal injury represents 3% and 30% of the company's annual revenue, respectively, but did not affect the company since the payout was through Insurance.
Impact on Stakeholders	The stakeholders impacted are the injured employee and the pedestrian.
Resolution	Both cases were settled out of court, with a verdict against the company. The company's insurance provider managed all aspects of the litigation process.
Management Practices	<ul> <li>The company had an employee safety training on safe driving practices while operating a truck and trailer.</li> <li>The company trained employees to document areas after mowing to show when tasks are completed and time-stamped.</li> </ul>
