SUMMARY OF ISSUE	As a vineyard and winery in Argentina, Penedo Borges operates in an industry in which biodiversity impact and monoculture agriculture are material environmental issues.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	"In the previous fiscal year, > 85% of Penedo Borges's revenue was earned from the sale of wine. 71% of the land under the company's control is cultivated as vineyard and 29% is uncultivated, in which the local flora is respected. Approximately 100% of cultivated land is planted with vineyards, which is a perennial crop. "
IMPACT ON STAKEHOLDERS	Agriculture, particularly in cases where a single crop is cultivated at a time, poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.

SUMMARY OF ISSUE	As a vineyard and winery in Argentina, Penedo Borges operates in an industry in which biodiversity impact and monoculture agriculture are material environmental issues.
IMPACT ON STAKEHOLDERS	"Penedo Borges practices are based on knowing the risks and acting in the most convenient way to minimize them.
	Some examples given by the company of their practices: 1) Rational use of irrigation water, avoiding surpluses so as not to send salts to the aquifer; 2) Power generation with solar panels to supply part of the energy used in the winery; 3) Treatment of residual water from the winery, making it suitable for irrigation; 4) Soil management, without plowing the soil with bars or discs, with a permanent cover of annual plants of different species that appeared spontaneously because of zero-tillage - these species (considered weeds in other vineyards) are managed by mowing performed after their seeds are ripe, so that when cutting them to control their height, they are replanted at the same time; 5) Management of agrochemicals, they are used under the concept of integrated control, prioritizing the control carried out by natural predators when there are any, and if they are not enough, using specific products for each pest at the right moments of their cycle to maximize the effect on it and minimize it on other species and on the environment. The aim is to have diversity of plants (grasses, legumes, cruciferous, composite, etc.) to achieve diversity of insects living on them, many of them natural predators of pests. Under the surface of the soil, worms, fungi and bacteria thrive, feeding on the organic matter from these plants and their roots. The soil management significantly increases the use of the natural fertility of the soil, which is why chemical fertilizers are usually not necessary.
	Because the vine is a long-lived perennial crop, crop rotation is not possible, but rational soil management in the inter rows (soil spaces between the rows) is. The company's vineyard has worked without plowing the soil with bars or discs, with a permanent cover of annual plants of different species that appeared spontaneously because of zero-tillage.  Penedo Borges uses pesticides under the concept of integrated control, prioritizing the control carried out by natural predators when there are any, and if they are not enough, using specific products for each pest at the right moments of their cycle to maximize the effect on it and minimize it on others. species and on the environment. Regarding chemical fertilizers, company's management of the soil mentioned increases the use of the natural fertility of the soil, so chemical fertilizers are not usually necessary and if so a dose of organic fertilizer composed of humic and fulvic acids is applied annually, which contributes to improving the physical structure of the soil and maintaining its biological activity."
