The breakdown of the percentages per industry is: 1. Alcohol: 1.43% 2. Animal Products or Services: 1.33% 3. Bottled water companies: 4.45% 4. For-profit higher education: 0% 5. Fossil Fuels - coal, oil sands: 0.35% 6. Fossil Fuels - other: 0.35% 7. Gambling: 0.23% 8. Industries at Risk of Human Rights Violations: 0.18% 9. Marketing of breastmilk substitutes: 4.45% 10. Impact on Stakeholders	B Lab's view is that companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, B Lab's view is that companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.

	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
