



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	2019
TOPIC	Significant layoffs due to employees' low performance
SUMMARY OF ISSUE	After several rounds of feedbacks, the company proceeds for the lay off of employees that did not present an improvement in their performance.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	22 employees were laid off, representing 22% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	The company claims to monitor and register the performance of each one of their employees. Every year, the information concerning each one of the workers is discussed among the managers and feedback is provided pointing out what are the main points of improvement. All decisions to lay off employees has to be well documented and follow the established internal procedures. Fortaleza S.A. de Inmuebles declares to follow all legal procedures and pay redundancy to employees according to the local legislation. They also have a protection policy for pregnant women.
RELATED INCIDENTS (YES/NO)	Yes. The company laid off 17% of their workforce in 2018 and 19% in 2020 due to employees' low performance.
