Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	Fleet Street is a communications and PR company that has had clients in the alcohol industry. The nature of the company's services with clients in these industries has been related to corporate and consumer communications, all services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients operating in the alcohol industry represented 13.64% in FY23-24.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact on stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not have any positions on working with clients in sensitive industries but does not work with natural resources companies or any company that makes products that could reasonably be considered to be harmful to their target consumer when consumed properly, as designed, and in moderation (ie Tobacco). The company conducts a thorough desktop search and our SLT hosts interviews with industry experts before onboarding a client. The company only works with brands that commit to responsible drinking practices. In addition, the company only works with brands that have an ongoing program in place to progress and improve its sustainability agenda. The company requires its clients to sign and follow their code of conduct.
