



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	The majority of the Navitas Organics layoffs were due to the decisions to outsource production, shipping and fulfillment work. Related to this decision, there were some additional layoffs due to restructuring of responsibilities and roles.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	<p>In June 2017, 28 employees were laid off when production work was outsourced, representing 31% of Navitas Organics' employees at that time.</p> <p>In July 2017, 2 employees were laid off, representing 1.8% of the company's employees at that time.</p> <p>In 2019, 8 employees were laid off, representing 10% of the company's employees at that time.</p> <p>In February 2020, 9 employees were laid off when shipping and fulfillment was outsourced, representing 15% of the company's employees at that time.</p>
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	<p>Employees were provided severance and, in some cases, stay bonuses.</p> <p>When the production team was laid off in June of 2017, employees were also given access to job placement support.</p>
OTHER MANAGEMENT COMMENTS	<p>Wherever possible staff was retained in other departments in the business.</p> <p>Since February 2020, Navitas Organics has experienced no layoffs.</p>
