

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Government Affairs, Lobbying/Advocacy and Political Activities
SUMMARY OF ISSUE	The company claims to be committed to improving access to medicines in Chile, seeking to offer pharmaceutical products at fair prices and making it more accessible to all Chileans. Given that, Fracción understands the importance of a state level solution, hence the company supports public policies and political initiatives that are in line with that objective.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the last 5 years, Farmacia Fracción has participated and advocated for the following laws and projects: i) Ley de Fraccionamiento; ii) Ley Cenabast; iii) Proyecto Comunas sin Farmacias; iv) Convenio Fonasa. Considering hours dedicated to participating in these topics, Fracción invested 60 hours of work in total in recent years, which is equivalent to \$1,164,688 CLP. In addition to this, it is estimated that \$3,370,000 CLP was invested in transportation to participate in these initiatives.
IMPACT ON STAKEHOLDERS	While pharmaceutical companies have the ability to lobby for policies that support their ability to maximize profit, the resulting risk to healthcare systems is significant. Companies engaged in lobbying for policies to keep the price of medications high and suppress competition and negotiation are prioritizing shareholder profits over stakeholder outcomes, which goes against the holistic stakeholder-focused approach of B Corp Certification.
IMPLEMENTED MGT PRACTICES	Fracción declares to be impartial towards all political tendencies, including no support to any specific political parties in any way. Given that the coverage and access to medicine is a public problem, the company defends collaborative models of relationship with public authorities such as the Ministry of Health, Instituto de Salud Pública, Secretarías Regionales Ministeriales de Salud, mayors and parliamentarians. Meetings with public authorities are requested via the government's website, following all protocols and regulations established by law. Information regarding meetings conducted between public authorities and Farmacia Fracción are publicly available. Examples of Farmacia Fracción involvement in government affairs include the support to the law of medicines fractionation - where any person can demand to buy only the required dose of a medicine -, to the legalization of online sales of pharmaceutical drugs, and to the CENABAST law - which establishes a maximum price for medicine sales.
