SUMMARY OF ISSUE	The Company is a cosmetics manufacturer, and produces handmade soaps as their main business. They have an office and a factory in New Taipei City, a farm in Yangmingshan National Park. The main water consumption is at the factory and the farm. The farm has no tap water supply
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the company's revenue is generated from the sale of manufactured products
IMPACT ON STAKEHOLDERS	<p>As a water intensive industry, the factory and the farm pose risks such as water stress if the water use is not appropriately managed. The factory is located in Tamsui District, New Taipei City. According to the Taiwan Water Supply Corporation - District 1 Management Office, Tamsui district is a water source, not a "water-stress area".</p> <p>The factory uses spring water of "Qingshui Stream in Yangmingshan National Park" for production. Tap water is used for the cleaning and sanitation of production equipment.</p> <p>At the farms, the irrigation spring water is from the "Qingshui Stream in Yangmingshan National Park". The farms also set up "ecological pool" to harvest rainwater as a supplementary water supply.</p>
IMPLEMENTED MGT PRACTICES	<p>Since the spring water is the excipient of products, the production ratio is fixed. Limited conservation of water can be implemented.</p> <p>The Company has water rights at the Yangmingshan National Park. Monthly water usage has to be recorded and monitored</p>

SUMMARY OF ISSUE	<p>The Company is a cosmetics manufacturer, and producing handmade soaps is the main business. They have an office and a factory in New Taipei City, a farm in Yangmingshan National Park. The main energy resource consumption is at the office and factory. The farm has no water and power supply infrastructure</p> <p>The main contributors to its carbon footprint are the Mixer (380V), electric furnace (380V) required in the production of handmade soap production process. The soap curing process takes 45 days, which uses air conditioner (220V) during the day time and dehumidifier (110V) at night.</p>
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	<p>100% of the company's revenue is generated from the sale of manufactured products.</p> <p>Annual total power consumption of 33,857 kWh (121.8852 Gigajoules)</p>
IMPACT ON STAKEHOLDERS	<p>As an energy and emission intensive industry, the factory poses environmental risks such as energy waste and greenhouse gas emissions and/or overuse if resources are not appropriately managed.</p> <p>The office and factory use electricity generated from the local power company.</p>
IMPLEMENTED MGT PRACTICES	<p>The Company has implemented a number of energy conservation practices, such as lights out for an hour during lunch break, setting personal computers to sleeping mode after idling for 5 minutes, and replacing traditional lighting equipment with LED equipment. Yuan Workshop has set the following goals:</p> <ul style="list-style-type: none"> 3% in 2023; 5% in 2024; 10% in 2025. <p>April 2022 is the base month to reduce electricity consumption, per capita and per unit floor area year by year:</p>

SUMMARY OF ISSUE	Yuan Workshop farms green herbs for use in the production of hand made soaps. The company's farm is located in an area suitable for recreational activities, within the Yangmingshan National Park; an area considered as ecologically sensitive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The Company's farm occupies 3.20 公頃/hectare within the Yangmingshan National Park
IMPACT ON STAKEHOLDERS	Having facilities near protected/sensitive ecosystems can potentially impact the flora, fauna and quality of the ecosystem (e.g. noise & light pollution from the facilities, spills, air / soil / water pollution owing to company's operations).
IMPLEMENTED MGT PRACTICES	<p>The company abides by the National Park Law. The farm has not been cultivated on a large scale, and the original landforms has not been changed. The farm only uses natural farming methods, KKF farming methods, and artificial organic compost for small-scale farming.</p> <p>Yuan Workshop does not have any buildings nor water or electricity infrastructures in addition to the farm within the National Park. Irrigation is carried out by using the height difference of the terrain to draw water from the stream.</p> <p>KKF farming methods: KKF(Khao Kwan Foundation) Natural Farming, the techniques of propagation of microorganisms and making liquid fertilizer. KKF microorganisms liquid, soybean dregs liquid fertilizer and fish liquid fertilizer can be used in vegetable and fruit gardens.</p>

REPORT	<p>YUAN grows herbs from its own farm located in the mountain, close to the Yangming National Preservation Park. By adopting unpolluted mountain spring water, Yuan grows herbs in YUAN Farm using organic methods.</p> <ul style="list-style-type: none"> In 2020, Yuan Farm won the "Green Conservation Product Certificate" by Mercy Organic Agriculture Development Foundation; In April 2022, the herbal plants planted in Yuan Farm also won the "Organic Agricultural Product Verification Certificate". The most precious Chinese medicine herbs are planted and grown on ecologically pure farms.
