<b>Topic</b>	Biodiversity Impact
<b>Summary of Issue</b>	AFYREN is a French greentech company that produces bio-based carboxylic acids from renewable, non-food biomass, as defined by standard EN 16640:2017. The company manufactures a fermentation co-product, which is processed and marketed as a potassium-rich fertiliser. All fertiliser products are certified by an attestation of conformity under Regulation (UE) n°2018/848 et n°2021/1165 for the Category : "Fertilizer and Soil Amendments". The company does not manufacture pesticides or plant protection products, and does not offer any products containing glyphosate.
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	In the last fiscal year, AFYREN generated around 80% of its revenue from the sale of bio-based carboxylic acids and 20% from the commercialization of fertilizer products.
<b>Impact on Stakeholder(s)</b>	Fertilisers can have an impact on biodiversity, water sources and affect air quality and human health.
<b>Implemented Management Practices</b>	<p>AFYREN products are registered and regulated under applicable European chemical legislation, including REACH registration with the European Chemicals Agency (ECHA) and classification under the CLP Regulation. Industrial activities are conducted under formal environmental authorisations issued by competent authorities. All products are derived from the transformation of renewable resources through a natural fermentation process, particularly using agricultural residues like sugar beet co-products. The company states that none of the products are synthetic. Additionally, AFYREN complies with EU Regulations 2019/1009, 2018/848, and 2021/1165.</p> <p>The environmental impacts associated with production are assessed using Life Cycle Assessment (LCA). Residual materials and wastewater generated from operations are managed through authorised treatment and disposal systems in accordance with applicable regulatory requirements. The company's manufacturing process aims to minimise waste generation. To preserve biodiversity, AFYREN has committed to sourcing only biomass co-products of European origin, thereby</p>



	<p>avoiding issues related to deforestation and land-use change. The company's industrial site has undergone an impact assessment, and management practices have been implemented as needed.</p> <p>To ensure a safe working environment for its employees, AFYREN has established an integrated management system that includes health and safety protocols. Employees receive training in safety procedures covering both industrial and chemical safety, and regular on-site drills reinforce these practices.</p> <p>AFYREN actively engages in discussions with stakeholders in the bioeconomy sector to understand their concerns. Product safety, handling, and regulatory information are provided to customers through safety data sheets and associated technical documentation.</p>
