



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

ISSUE DATE	March 2020
TOPIC	Significant layoffs due to COVID-19.
SUMMARY OF ISSUE	<p>Due to the impacts of Covid 19, the company implemented one round of layoffs in March 2020. The strict lockdown measures set by Hawaii to combat the pandemic resulted in a 14-day quarantine for anyone traveling to island. This heavily impacted the tourism industry on which the company depended. Only 'essential' businesses were able to remain open and a stay-at-home order was in place until June 2020. At the end of 2020, a COVID testing pilot program was trialed that allowed visitors to come to the state without quarantine if they showed a negative test results within 3 days of their flight to Hawaii. The visitor industry did not rebound until January of 2021.</p>
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	8 employees were laid off, representing 100% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	<p>The company complied and sent emails to their employees on what aid was available in their country, state, and federal agencies and guidance on how to apply for those funds. As a result, the laid-off employees received unemployment and federal cares act money. The company's full-time year-round staff received unemployment benefits and some employees were able to work with a nonprofit organization that the company works with, Hawaii Land Trust. The company brought back the year-round staff for partial employment as soon as the stay-at-home orders were lifted in June 2020. However, there was no real work for them until December 2020 to January 2021. The employees continued to receive unemployment benefits the entire time and if they worked, they reported those hours, which were deducted from the state benefits.</p>
