



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As a vineyard and winery, Dolium Bodega Subterranea operates in an industry in which biodiversity impact and monoculture agriculture are material environmental issues.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 90% of revenue was earned from the sale of wine 3 hectares out of 17 hectares of land under the company's control is cultivated as vineyard, 12 hectares are cultivated with rotating crops, and 2 hectares are uncultivated.
IMPACT ON STAKEHOLDER(S)	Agriculture, particularly in cases where a single crop is cultivated at a time, poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
IMPLEMENTED MGT PRACTICES	Dolium Bodega Subterranea does not currently have any specific targets related to preserving or conserving biodiversity. The land area of its cultivated vineyards, 3 hectares, represents only a small fraction (0.001%) of the planted vineyards in Argentina. The company manages its impact by following the instructions of INV (for the winery) and SENASA (for the vineyard), and by prioritizing the use of organic fertilizers.

SUMMARY OF ISSUE	As a vineyard and winery, Dolium Bodega Subterranea operates in an industry that is water intensive. Aspects of the industry that make it water intensive include irrigation used in the cultivation of vines, and water used in the winemaking process.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the company's vineyards are irrigated by inundation.
IMPACT ON STAKEHOLDER(S)	As water intensive industries, agriculture and wine production poses risks such as water stress or depletion of local water sources if water use is not appropriately managed.
IMPLEMENTED MGT PRACTICES	Dolium Bodega Subterranea does not currently have any specific targets related to water conservation.
