Disclosure Questionnaire Category: Litigation

Issue Date	2019
Topic	Settlement for professional liability insurance for building design and architecture oversight of a project carried out 10 years prior.
Summary of Issue	Carleton Har Architecture was cited as a third party in a case initiated by the building owner against various Contractors and Subcontractors. The core of the allegations centered on water intrusion and damages supposedly resulting from incorrectly installed siding, trim, flashings, caulking, water-resistant barriers, roofing, windows, exterior decks and stairs. The construction projects were completed in 2009, yet the report was only filed in 2019.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	1-5% of the company's annual revenue.
Impact on Stakeholders	Building Owner and residents.
Resolution	Case settled in January 2020, Carleton Hart insurance paid the building owner.
Implemented Management Practices	CHA has increased QA/QC throughout the construction administration to avoid such cases from arising in the future.
