Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Suppliers Negative Environmental Impact

Topic	Avocado Suppliers
Summary of Issue	Chosen Foods earns their revenue from products made from avocado, which can potentially negatively impact the biodiversity of the areas where the company sources their avocados.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	96% of Chosen Foods revenue is earned from the sale of avocado related products. The company does not own the production of the products as they are only the distributors.
Impact on Stakeholders	The potential environmental impact is specific to biodiversity and monoculture. The avocados are grown in groves and are not inter-cropped, which can negatively impact biodiversity by reducing habitat for different species. The groves are a monoculture because the trees can't be rotated in the way that other crops can. The impacts of avocado groves are similar to the environmental impacts of growing wine grapes, coffee, cacao, and other fruit, which are not inter-cropped nor biodiverse.
Implemented Management Practices	The products that Chosen Foods sells are made primarily from bruised or damaged avocados that would otherwise end up in waste streams. Chosen Foods monitors potential environmental impacts through regular visits to their suppliers' operations to ensure waste reduction practices and growing practices are aligned with the company's expectations and standards. In addition, Chosen Foods partners with farmers and suppliers to make use of all avocados, especially the avocados that are not fit to make it to the market, which ensures that there is as little wasted crop as possible. During the oil extraction process, any leftover matter is transformed into natural gas, animal feed or fertilizer for the fields.
Other Management Comments	The company also has a policy of Glyphosate-Free for its conventional, non-gmo products to discourage the use at the farm level. Additionally, the company has worked to create a market for Organic Avocado oil which has encouraged the expansion of Organic farming practices in Mexico and around the world in response to creating demand for organic options.
