



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	6.12.2022
TOPIC	Litigation on a peanut allergy case
SUMMARY OF ISSUE	The company is facing pending litigation related to peanut sauce in a burrito ordered by a customer who stipulated otherwise due to having a child with a peanut allergy. The child was injected with an epi-pen and admitted to the ER for further observation due to potential harm.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The case is still pending with an estimation \$500,000 of claim, with a break down of \$3,000 for the hospital bill and the remaining \$497,000 claim is for damages to the child's psychological & mental health.
IMPACT ON STAKEHOLDERS	The affected family was the main impact stakeholder. Food allergies may cause significant potential harm to consumers with allergic reactions. The harm can be both physical (from minor to severe physical reactions) and psychological (such as fear of going to the restaurant or trying any new food).
IMPLEMENTED MGT PRACTICES	After that incident, the company implemented a new allergen procedure and conducted "ServSafe" & CPR training on August 11 2021 to ensure all employees are "ServSafe Certified" in Allergens and a few other allergen training 2021. On top of that, the company removed one of its famous dishes, Bangkok Thai dish, from the menu as it contains peanuts.
