

DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Water Intensive Industries
SUMMARY OF ISSUE	The Nestlé Health Science portfolio includes food and beverage products. Food and beverage manufacturing can be water intensive due to cleaning and production processes.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Nestle Health Science US's onsite water intensity for 2021 was approximately 4.2 cubic meters/tonne of product produced.
IMPACT ON STAKEHOLDERS	As a water intensive industry, food and beverage production poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. In the case of Nestlé Healthcare Nutrition, water is sourced from a municipality water system.
IMPLEMENTED MGT PRACTICES	Nestlé Healthcare Nutrition is currently working to further reduce the water required for CIP (cleaning in place) processes by reducing rinse timers, and recovering rinse water for reuse. We are also making investments in Reverse Osmosis(RO) water generation by increasing recovery rates to reduce the overall factory water withdrawal by approximately 10%. Nestlé Healthcare Nutrition is a Nestlé Health Science U.S. business. In 2021, Nestlé Health Science U.S. partnered with the U.S. Dept of Energy Better Plants Program to compare its water consumption among other measures of sustainability with others in the industry. While we have already made significant progress, we continue to look for ways to decrease our future water consumption.
